

POST WAR PLANS

THE WEST 250 FT. OF THIS TRACT SHALL BE RESERVED FOR THE NAVAL RESERVE ARMORY.

BUILD A STEEL AND CONCRETE BULKHEAD ALONG THE ENTIRE WATERFRONT, INCLUDE A 6 FT. WIDE DOCK THE ENTIRE LENGTH FOR PLEASURE BOAT DOCKAGE. THIS WILL BE SUBJECT TO A SMALL RENTAL FOR ITS USE.

BUILD 3 RAIN SHELTERS ALONG THE WATERFRONT, ABOUT 20' x 50' EACH, OF CONCRETE CONSTRUCTION.

CLOSE ALL STREETS IN THIS AREA, SCARIFY PAVING, REMOVE SIDEWALKS AND CURBING, FILL, TOPSOIL AND LANDSCAPE AREAS LEFT BY STREET REMOVAL.

CONSTRUCT A LARGE COMMUNITY BUILDING WITH ASSEMBLY ROOM, STAGE, DRESSING ROOMS, TOILETS, OFFICES AND MEETING ROOMS. THIS BUILDING SHALL FRONT ON N. W. 7TH STREET NEAR THE CENTER OF THE TRACT.

A BATTERY OF 10 SHUFFLEBOARD COURTS SHALL BE CONSTRUCTED FLANKING THE EAST SIDE OF THE COMMUNITY BUILDING.

IN THE SOUTHEAST CORNER, A SMALL BANDSTAND AND OPEN AIR THEATRE SURROUNDED BY A PAVILION SHELTER. THE ENTIRE FLOOR IN THIS AREA SHALL BE TERRAZZO FOR COMMUNITY ENTERTAINMENT AND DANCING.

A CHILDREN'S APPARATUS AREA WITH WADING POOL AND SHELTER SHALL BE PLACED WEST OF THE COMMUNITY BUILDING NEAR N. W. 7TH STREET.

A BASKETBALL AND VOLLEYBALL COMBINATION COURT, 110 x 110 FT. SQUARE, OF ASPHALT PAVING WITH A 6 x 10" CONCRETE HEADER AROUND THE PERIMETER, AND SHALL BE CONSTRUCTED IN THE SOUTHWEST CORNER OF THE PARK.

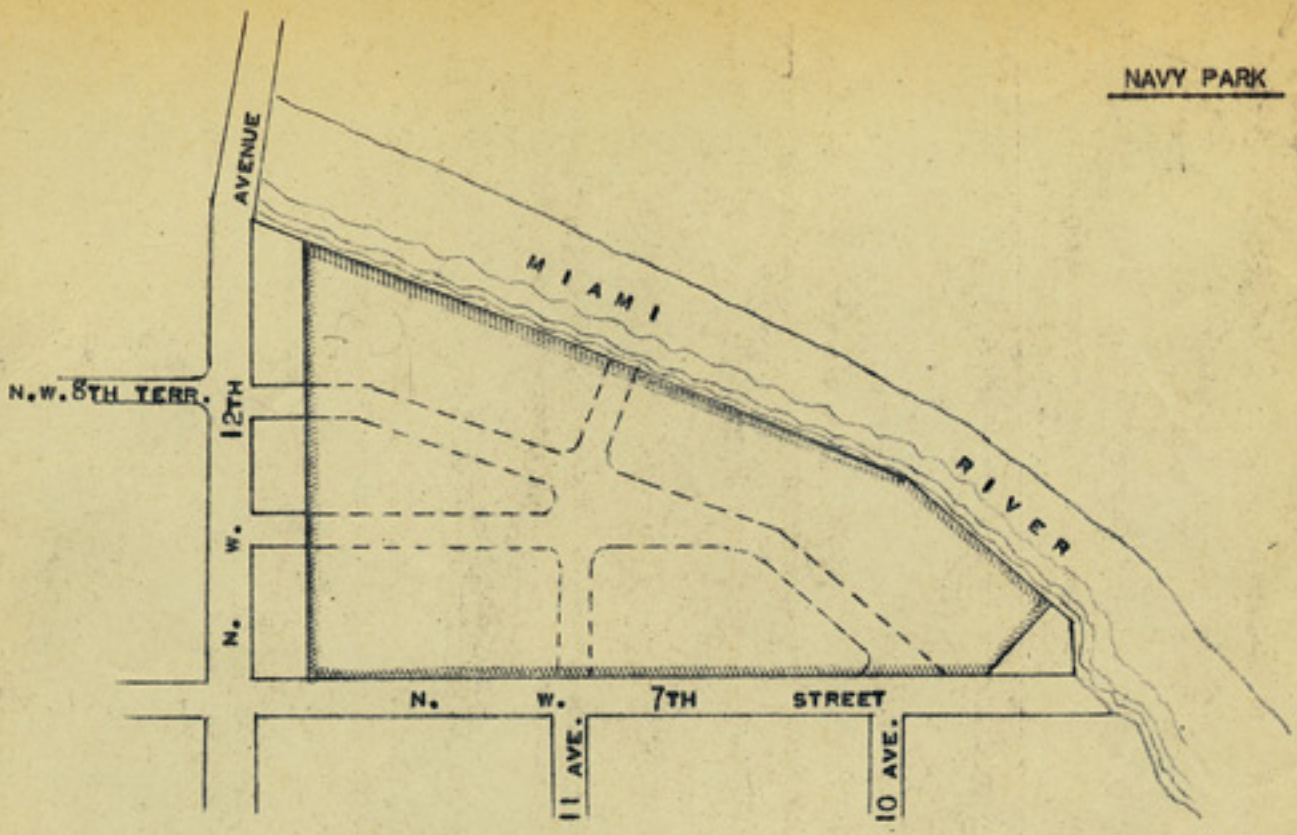
AN ATHLETIC FIELD CONSISTING OF A TOUCHBALL FIELD, A SOFTBALL DIAMOND AND A BAIT CASTING AREA SHALL BE PLACED ON THE NORTH.

FLOODLIGHT THE ENTIRE AREA.

A SPRINKLER SYSTEM SHALL BE PROVIDED TO GIVE COMPLETE COVERAGE TO THE LAWN AREAS.

A 6' CHAIN LINK FENCE SHALL BE PLACED ALONG THE BOUNDARY LINE. THE ENTIRE AREA SHALL BE LANDSCAPED, ADEQUATE SHADE TREES AND WALKS PROVIDED.
