# MINUTES OF SPECIAL MEETING OF THE COMMISSION OF THE CITY OF MIAMI, FLORIDA

On the 18th day of September, 1947, the Commission of the city of Miami, Florida, met at the City Hall in said City in a special session, called by Mayor Perrine Palmer, Jr., for consideration of business of public import. The meeting was called to order at 2:03 o'clock P.M. by Chairman Perrine Palmer, Jr., and on roll call the following members of the Commission were found to be present: Messrs. He pointed out that the establishment is approximately 50 feet from the Children's Home Society and less than 300 feet from the church, and requested the revocation of the license.

WHEREAS, the Director of Finance has requested that he be authorized to destroy or cause to be destroyed by cremation, any and all paid or cancelled bonds, revenue certificates and coupons appurtenant thereto, a record of which will be maintained in the Finance Department files in the form of a cremation certificate signed by the Director of Finance and the Chief Accountant, or in instances where such cremation is done by a paying agent, the cremation certificate will be signed by an authorized official of the paying agent;

The following resolution was introduced by Mr. Hosea, who moved its adoption:

RESOLUTION NO. 20206

A RESOLUTION AUTHORIZING THE DIVISION OF POLICE TO USE APPROXIMATELY FIVE (5) ACRES OF REAL ESTATE HERETOFORE PURCHASED BY THE CITY FOR PARK PURPOSES, AS AN AUTOMOBILE TESTING STATION, SUCH PROPERTY BEING

# SITUATED IN THE VICINITY OF NW 62ND STREET AND 67TH STREET, AND BETWEEN NW 4TH COURT AND NW 5TH COURT

WHEREAS, the City Commission of Miami, under Resolution No. 16658 authorized purchase of certain real estate comprising approximately fifteen (15) acres as hereinafter described; and

WHEREAS, ten (10) of the said fifteen (15) acres is now being utilized as a park and playground area, leaving five (5) acres thereof not being utilized; and WHEREAS, it is possible to use remaining five (5) acres as an automobile testing station to relieve congestion accompanying such testing;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF MIAMI: Section 1. That the Division of Police of the City of Miami is hereby authorized to use for an automobile testing station the following described real estate:

### BIDS - CONCESSION AT DINNER KEY:

The City Manager reported that the time for receiving sealed bids for concession rights at Dinner Key has been deferred from September 17th to October 1st.

### CANCELLATION OF PERMITS - BLUE & GRAY AND YELLOW CAB COMPANIES:

The Commission discussed the question of the revocation of permits for the operation of taxicabs where the holders thereof have failed to place the taxicabs in service in accordance with the provisions of Resolutions numbered 19480 and 19655.

The City Manager submitted a report on permits not in use as of January 1, 1947.

The following resolution was introduced by Mr. Dunn, who moved its adoption:

#### RESOLUTION NO. 20207

A RESOLUTION REVOKING AND CANCELING CERTAIN PERMITS ISSUED UNDER CERTIFICATES OF PUBLIC CONVENIENCE AND NECESSITY TO THE BLUE & GRAY CAN COMPANY AND THE YELLOW CAB COMPANY FOR THE OPERATION OF TAXICABS IN THE CITY OF MIAMI FOR FAILING AND NEGLECTING TO PLACE IN SERVICE SAID TAXICABS AFTER DUE NOTICE

WHEREAS, the City Commission did on the 9th day of July, 1946, give notice of its intention to revoke permits for the operation of taxicabs in the event that the holders thereof shall fail or neglect to place in service and operate by November 1, 1946, the total number of taxicabs covered by the certificate of Public Convenience and Necessity; and

WHEREAS, by Resolution No. 19655 the said holders of permits were given an extension from November 1st, 1946, to January 1st, 1947, as shown by Resolution No. 19655: and

No. 19655; and

WHEREAS, the said holders have still failed and neglected to comply with the resolution and place in service and operate the number of taxicabs covered by said certificates of Public Convenience and Necessity, although having had adequate notice, time and opportunity to do so;

Section 2. That the permits herein cancelled and revoked covering the above taxicabs have never been used and the said taxicabs have never been operated under the same as of January 1st, 1947, and the owners have failed and refused to comply with the resolutions of the Commission heretofore passed notifying them that the said permits would be revoked and cancelled if said cabs were not put in operation and use.

Section 3. That the number of permits under the certificates of Public convenience and Necessity heretofore issued to Blue & Gray Cab Company is reduced by 18, and the number of permits under the Certificates of Public Convenience and Necessity heretofore issued to Yellow Cab Company is reduced by 20.

Upon being seconded by Mr. Thomson, the resolution was passed and adopted by the following vote - AYES: Messrs. Dunn, Hosea, Palmer, Thomson. NOES: Mr. Gardner.

Prior to roll call Mr. Gardner offered an amendment to the motion to provide that all permits to be cancelled be given to ex-G.I.s to operate ten-cent jitneys, in order to create better transportation in which the bus company has so miserably failed. There was no second to the amendment.

On roll call Mr. Gardner stated that he would vote "no" unless the commission agreed to give the permits to ex-G.I.s, so that the city would have better transportation.

Mr. Dunn stated that he had suggested jitney service, but that Mr. Gardner had stated that jitneys would not provide good service.

Mr. Thomson pointed out that the Commission had gone on record to accept applications for additional permits for taxicabs and to issue permits in the order in which the applications were received.

#### LIQUOR ORDINANCE AMENDMENT:

Attorney Abe Aronovitz appeared in reference to a proposed ordinance passed on first reading at the meeting of September 10th and entitled:

AN ORDINANCE PROVIDING FOR THE RIGHT OF REMOVAL OF A LIQUOR LICENSE HERETOFORE ISSUED TO A PLACE WITHIN 300 FEET FROM A LOCATION TO WHICH IT HAS BEEN ISSUED, PROVIDED THE NEW LOCATION IS NOT OTHERWISE IN CONFLICT WITH ALREADY EXISTING ZONING LAWS, EXCEPT FOR DISTANCE, AND PROVIDED FURTHER THAT NO SUCH RIGHT OF REMOVAL SHALL BE GRANTED EXCEPT IN SUCH CASES WHERE EVIDENCE IS FURNISHED TO THE CITY COMMISSION THAT IT IS NECESSARY FOR THE LICENSEE TO REMOVE FROM HIS ALREADY EXISTING PREMISES BY REASON OF DIFFICULTIES WITH THE LANDLORD OF THE SAID PREMISES; REPEALING ALL LAWS IN CONFLICT HEREWITH

and stated that he had made certain changes in the ordinance as suggested by the city Attorney.

Mr. Thomson stated that he did not know whether he would be in favor of the ordinance if it would permit liquor establishments to operate next door to one another.

Mr. Aronovitz explained that under the zoning regulations the distance between liquor establishments in the downtown area is fixed at 500 feet, and in the outlying sections at 2500 feet, so that under the proposed ordinance a licensee could not move his business closer than 200 feet to another establishment in the downtown section or 2200 feet in the outlying sections, with the exception of a few places that were established prior to the adoption of the zoning regulations.

Mr. Dunn stated that he would not be in favor of the ordinance if the commission did not have control of a transfer of license from one location to another.

Mr. Thomson stated that it would circumvent the Planning Board.

In reply to a question by Mr. Thomson as to whether or not this would be the proper procedure without clearing through the Planning Board, the City Attorney stated that he could see no objection to the ordinance as the transfers would be under the control of the commission and that the Planning Board deals primarily with classification of property. He stated that this is a matter of policy. He pointed out that he had suggested the following changes in the proposed ordinance:

1. To add "if approved by the Commission" after the word "right" in the second line under Section 1.

2. To add "between established licensees" after the word "distance" in the 5th line under Section 1.

3. To add to Section 1 "Nothing contained herein shall be construed to grant power to locate any liquor business within the prescribed distance limitations from churches or schools".

Thereupon the ordinance, as amended, and entitled:

AN ORDINANCE PROVIDING FOR THE RIGHT OF REMOVAL OF A LIQUOR LICENSE HERETOFORE ISSUED TO A PLACE WITHIN 300 FEET FROM A LOCATION TO WHICH IT HAS
BEEN ISSUED, PROVIDED THE NEW LOCATION IS NOT OTHERWISE IN CONFLICT WITH
ALREADY EXISTING ZONING LAWS, EXCEPT FOR DISTANCE BETWEEN ESTABLISHED
LICENSEES, AND PROVIDED FURTHER THAT NO SUCH RIGHT OF REMOVAL SHALL BE
GRANTED EXCEPT IN SUCH CASES WHERE EVIDENCE IS FURNISHED TO THE CITY COMMISSION THAT IT IS NECESSARY FOR THE LICENSEE TO REMOVE FROM HIS ALREADY

# EXISTING PREMISES BY REASON OF DIFFICULTIES WITH THE LANDLORD OF THE SAID PREMISES; REPEALING ALL LAWS IN CONFLICT HEREWITH

was introduced by Mr. Dunn, seconded by Mr. Gardner, and passed on first reading by title only by the following vote - AYES: Messrs. Dunn, Gardner, Hosea. NOES: Messrs. Palmer and Thomson.

Mr. Palmer stated that he was opposed to circumventing the Planning Board in reference to liquor licenses.

# TRANSFER OF FUNDS - HURRICANE CLEAN-UP EXPENSE:

Ray Williams, Director of the Department of Engineering, reported that he had made an investigation as to the amount of material to be removed as the result of the hurricane and that the volume appears to be less than after the 1945 hurricane. He stated that he does not know how long it will take to remove debris, but based on hiring six cranes and 25 private trucks and using the City's equipment and operating the trash trucks on double shifts and the garbage trucks an extra shift for removal of trash, the average daily expense will be \$4,790.00.

Mr. Gardner stated that after the 1945 hurricane, the city spent a lot of money and hired heavy equipment which damaged the pavement.

The City Manag er stated that there are not sufficient funds available in the waste and Park Division accounts to cover the cost of removing and disposing of the debris.

Messrs. Dunn, Hosea, Palmer and Thomson expressed themselves as being in favor of proceeding immediately with the work of cleaning up the streets.

The following resolution was introduced by Mr. Dunn, who moved its adoption:

# RESOLUTION NO. 20208

A RESOLUTION TRANSFERRING THE SUM OF \$75,000 FROM THE CONTINGENT FUND TO A SPECIAL CODE OR CODES TO PROVIDE FOR THE PAYMENT OF HURRICANE CLEAN-UP EXPENSES, PENDING OTHER MEASURES TO FINANCE THE SAID EXPENSE

WHEREAS, preliminary estimates of the expense of removing and disposing of the debris following the tropical storm of September 17, 1947, show a probable cost in excess of \$200,000; and

WHEREAS, the 1947-48 appropriations contain no provision for such expense, and provision must be made therefor by the adoption of a special revenue or by elimination of portions of the provisions in the 1947-48 appropriations, and the diversion of the funds thereby released to the storm debris clean-up; and

WHEREAS, it is necessary immediately to provide funds to permit the commencement of this emergency work, pending more definite and final provision therefor, and such temporary provision can be made from the 1947-48 contingent Fund;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF MIAMI:
There is hereby transferred from the Contingent fund the sum of \$75,000.
to provide for the removal and disposal of storm debris, said sum to be repaid
to the Contingent Fund out of any funds made available by more definite financing of the storm clean-up expense.

Upon being seconded by Mr. Thomson, the resolution was passed and adopted by the following vote - AYES: Messrs. Dunn, Hosea, Palmer, Thomson. NOES: Mr. Gardner.

Mr. Gardner expressed the opinion that the trash can be removed within two weeks without extra equipment.

# ADJOURNMENT:

There being no further business to come before the commission at this meeting, on motion duly made and seconded, the meeting was adjourned at 4:55 o'clock P.M.
