ARTICLES OF INCORPORATION OF

DORSEY OIL CORPORATION

This corporation is organized under the Corporate Law known as Chapter 10096, Laws of Florida, Acts of 1925, entitled:
"An Act Relating to Corporations"

ARTICLE I.

The name of this Corporation shall be "DORSEY OIL CORPORATION".

ARTICLE II.

The nature of the business of the Corporation and the objects and purposes to be transacted, promoted and/or carried on by it are:

Sec. 1. To do all kinds of prospecting, promoting, engineering, mining, digging, boring, drilling, building, constructing and/or other kinds of work incident and necessary in an effort to obtain from the earth oil, petroleum, gas and all other volatile mineral substances; to manufacture, refine, prepare for market, buy, sell and transport oil, petroleum, gas and/ or all other mineral substances, their products and by-products and to transport the same in the crude or refined condition; to acquire for these purposes gas and oil lands, lease holds and other interests in real estate; to construct and maintain conduits and lines of tubing and piping for the transportation of natural gas and/or oil for the public generally as well as for the uses of said corporation; to transport such oil and gas and other mineral substances by means of such pipes, tanks, cars or otherwise and to sell and supply the same to others; to lay, buy, lease, sell and operate pipes, pipe lines and storage tanks to be used for the purpose of transporting and storing oils and gas and other mineral substances, and of doing a general pipe line and storage business; to construct and maintain gas wells, oil wells and refineries, and to buy, sell and deal in gas and oil; to construct and maintain all private railways, tramways, telegraphand telephone lines necessary or convenient in the prosecuting of the business of the corporation: to build, construct, purchase, maintain, own and operate warehouses, pumping plants, refineries, factories, mills, work shops, laboratories and dwelling houses for workmen and others; to manufacture, buy, sell, import, export and

deal in pumps, drills, fuses, cups, candles, nitroglycerine, dynamite and other necessary machinery, engines, drills and all appliances and conveniences for use in connection with mining and drilling for oil and gas; to cut, manufacture and selltimber from the lands of the corporation; to obtain and prepare for market such other valuable minerals or materials as may be discovered in developing the lands of the company; to carry on in connection with any or all of said purposes the business of buying and selling goods, wares and merchandise.

Sec. 2. To acquire, buy, purchase or otherwise deal in real estate and to hold, sell, lease, mortgage, encumber or improve the same in any and all respects as fully and completely as any individual might do.

Sec. 3. To survey, subdivide, plat, improve and develop in any and all kinds of ways for any and all purposes, including the sale thereof, for residences, trade and business.

sec. 4. To subscribe for, purchase, invest in, hold, own, assign, pledge, encumber and otherwise deal in and dispose of shares of capital stock, bonds, mortgages, debentures, notes and other securities, obligations, contracts and evidences of indebtedness of this corporation and of other corporations wherever located.

Sec. 5. To lend money and to negotiate loans for itself or other corporations, co-partnerships and individuals; to form, promote, subsidize and assist companies, syndicates and partnerships of all kinds; to give any guarantee for the payment of money or the performance of any obligation or undertaking; to undertake and execute any trusts; to acquire, improve, manage, work, develop and exercise all rights in respect of leases, mortgages, bonds and otherwise deal with andin property of all kinds; to enter into any arrangements or contracts with any authorities, Municipal, County, State, Federal, or otherwise, that may seem conducive to the corporation's objects and purposes, or any of them, and to obtain from any such authority any rights, privileges and concessions which the corporation may think it desirable to obtain, and to carry out, exercise and comply with any such arrangments or agreements.

Sec. 6. And to do and transact any and all forms of business properly connected with or incidental to any or all of the objects or purposes of this corporation.

ARTICLE III.

Sec. 1. The capital stock of this corporation shall be one
Hundred Fifty Thousand & no/100 (\$150,000.00) Dollars, which shall be divided
into Fifteen Thousand (15,000) shares, the maximum number of shares of stock
to be issued in this corporation, each to be of the par value of Ten &
No/100 (\$10.00) Dollars. Said stock shall be non-assessable and the personal property of the stockholders, who shall in no event be responsible for
or subject to the debts of said corporation.

Sec. 2. The amount of capital with which the corporation shall begin business is Five Hundred & No/100 (\$500.00) Dollars or more and said corporation shall be permitted to take in payment for its stock money, professional and other services of any and all kinds and/or properties of any and all kinds, all and each of which are to accepted at its fair market value to be determined by the Board of Directors of said corporation.

ARTICLE IV.

The period of existence and the duration of the life of this corporation shall be pereptual.

ARTICLE V.

The principal office and place of business of this corporation shall be in the City of Miami, Dade County, Florida, and it may establish offices in other Cities, States and in foreign countries.

ARTICLE VI.

The business and prudential affairs of this corporation shall be managed and controlled by a Board of Directors to be elected annually, or as otherwise provided in the By-Laws, such board to consist of not less than three (3) nor more than five (5) persons.

ARTICLE VII.
