3. Organizers, agents, or officers of Councils are not authorized to make or modify this or any other contract in behalf of the Association and cannot extend the time of any payment, nor give credits, nor waive forfeiture, nor bind this Association in any way beyond its statements herein.

4. Whenever this Certificate becomes a claim by death, any error in understating the age of the member will be adjusted by the payment of such an amount as the payments made would have purchased at the correct age, and any indebtedness to the association on account of this Certificate and the payments for the balance of the Certificate year, if any, will be deducted.

5. This Certificate shall be binding only if delivered while the member is alive and in good health, and payments made in accordance with the terms hereof.

6. Failure to make required payments hereon during sickness or disability will void this Certificate after the payment becomes overdue. In case of the fatal termination of a disability, only the death benefit shall be due.

7. No suit shall be brought against the Association after twelve months from the date of occurrence of any alleged claim, and should suit be brought thereafter the lapse of time shall render it null and void as well as any benefits that may be due hereunder.

8. Sickness or disability is a condition confining the member to bed and under the treatment of a regular physician. Benefit will not be paid where a physician is not in attendance at least twice a week, except at option of the Association. A member must be entirely disabled from attending to any part of his or her occupation to be entitled to benefit. Not more than twelve weeks will be paid in any one year for accident or disability.

9. In the event of disability it shall be the duty of the member to immediately notify the Home Office of the Association. Benefits shall only be allowed from the time such notice is sent, and for a period of not less than seven days. In case of dispute as to time such notice is sent, the time shall be reckoned from the time of its receipt at Home Office.

10. No benefits shall be paid hereunder for any sickness or disability commencing within two months from the date of this Certificate, after which time one week's benefit will be allowed for each two completed months of membership during the first year, and thereafter not exceeding twelve weeks in any year except that no more than six weeks can be drawn during any six months.

11. Benefits will not be paid in case of sickness or death from intemperance or immorality nor for diseases contracted before Johning the Association,

nor for injuries received in a fight or while violating the law; nor will sick benefits be paid for rheumatism, venereal diseases, diseases peculiar to women, or cancer of the mammae or of the uterus except that one week's benefit will be allowed for each confinement occuring after one year's membership. Not more than two weeks' benefit will be allowed in any year for malarial diseases, la grippe, synovitis, influenza, plics, or neuralgic diseases, and not more than one week's benefit will be allowed in any year for sprains or eczema except at the option of the Association.

12. When a member becomes permanently totally disabled, only one-half of the amount of the disability benefit mentioned in this Certificate shall be payable each year. Benefits so paid shall be deducted from the amount of the Certificate when it becomes a claim on death of member.

is. In case of the death of the member within six months of the date of this Certificate, but one-fourth of the amount otherwise due shall be payable hereunder; one-half after six and within nine months, and three-fourths after nine months and within one year.

14. The Association also reserves the right to cancel this Certificate by returning to the member twice the amount of monthly payments made hereon, less benefits drawn, should the member at any time within one year of the date of this Certificate be afflicted with a chronic disease.

15. By the acceptance of this Certificate, the member waives any and all provisions of law which may require a copy of the application for this Certificate, or the laws of the Association, to be attached hereto, with the proviso that the member may procure at any time a copy of said application and laws upon request.

16. The Warranty and Agreement, and Forms A and B of the application for membership, are hereby made a part of this contract as specifically as if they were hereon recited.

17. Receipts for payments on this Certificate will not be valid except upon regular printed forms issued by the Association for the purpose.

18. This Certificate shall be void if there is in force on the life of the member a Certificate previously issued by this Association, unless one Certificate contains an endorsement signed by the Secretary authorizing the other to be in force.

19. The member to whom this Certificate is issued shall be liable for at least one payment each calendar month in the amount named in the Title Page of this Certificate without further notice or call than herein given.

20. In case a member is shot, whether by his own hand or not, not more than two weeks' benefit will be allowed, except at option of the Association. If death results, only one-fourth of amount otherwise payable shall be due.

 In case of accident or death due to hazardous occupation, only one-fourth of the amount otherwise payable shall be due.

22. No clerical error in this Certificate shall operate to deprive the member of any right or benefit, or expose the Association to any liability but shall be construed to be corrected to conform to the laws, rate, tables and regulations of the Association, and upon disclosure shall be corrected accordingly.

23. Any indebtedness of a member or the beneficiary to the Association shall be deducted from the sum due under any Certificate in case of any claim.

24. If death should occur within two years of the date of this certificate, and should said death occur wholly or partially, directly or indirectly, because of tumor, cancer, apoplexy, paralysis or any form of heart, lung or kidney diseases, only half of the amount otherwise provided in this certificate shall be due and payable by the Association.

Extra Accident Benefits

If a member is disabled by an accident the amount of benefit paid will be 25 per cent higher than in case of illness, in accordance with the conditions of the By-Laws, provided the accident is not the result of carelessness.

Special Accident Benefits

in case of the loss of one eye, one foot, or one band, by accidental means, the member is at once paid one-half of the death benefit then due.

In case of total paralysis, of one year's duration, according to the rules of the Association, the member, at his option, can surrender the certificate for half the death benefit then due.

In case of the loss of one hand and foot or of eyesight of both eyes, or of both hands, or of both feet, by accidental means, the member is entitled to be paid the death benefit then due.
