part Y of the second part, WITNESSETH, that the said party of the first part, for and in consideration of the sum of One Hundred dollars and other valuable considerations to him in hand paid, the receipt whereof is hereby acknowledged, has granted, bargained, sold and transferred, and by these presents does grant, bargain, sell and transfer unto the said party of the second part and his heirs and assigns forever, all that certain parcel of land lying and being in the County of Dade and State of Florida, more particularly described as follows: Lots Eleven (11) and Twelve (12) of Block Three (3) of Sost's Subdivision of Lot One (1), in Section Thirty-six (36), Township Fifty-three (53) South, Range Forty-one (41) East, as per plat recorded in Book 13 of Plats at Page 27, in the office of the Clerk of the Circuit Court of Dade County, Florida,
