

SPECIAL WARRANTY DEED
(FROM CORPORATION)

This Indenture, Made the 28th day of April, in the year of our Lord one thousand nine hundred and thirty one

WITNESSETH, That the said party of the first part, for and in consideration of the sum of Ten Dollars and other good and valuable considerations (\$10.00) Dollars, lawful money of the United States of America, to it in hand paid by the said party of the second part, at or before the ensembling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, aliened, remised, released, conveyed and confirmed, and by these presents does grant, bargain, sell, alien, remise, release, convey and confirm unto the said party of the second part, and his heirs and assigns forever, all the following piece, parcel or tract of land, situate, lying and being in the County of _____, State of Florida, and more particularly described as follows:

TOGETHER with all and singular the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, and the reversion and reversions, remainder and remainders, rents, issues and profits thereof, and also all the estate, right, title, interest, property, possession, claim and demand whatsoever, as well in law as in equity, of the said party of the first part of, in and to the same and every part and parcel thereof, with the appurtenances.

TO HAVE AND TO HOLD the above granted, bargained and described premises, with the appurtenances, unto the said part Y of the second part, his heirs and assigns, to his own proper use, benefit and behoof forever.

And the said party of the first part, for itself and for its successors, does covenant, promise and agree to and with the said part Y of the second part, his heirs and assigns, that the said party of the first part, at the time of the ensealing and delivery of these presents, is lawfully seized of and in all and singular the above granted, bargained and described premises, with the appurtenances, and has good right, full power and lawful authority to grant, bargain, sell and convey the same in manner and form aforesaid. And the said part Y of the second part, his heirs and assigns, shall and may at all times hereafter peaceably and quietly have, hold, use, occupy, possess and enjoy the above-granted premises and every part and parcel thereof, with the appurtenances, without any let, suit, trouble, molestation, eviction or disturbance of the said party of the first part, its successors or assigns, or of any other person or persons lawfully claiming or to claim the same by, through and under the grantor herein.

And the said party of the first part, for itself and for its successors, the above described and hereby granted and released premises, and every part and parcel thereof, with the appurtenances, unto the said part Y of the second part, his heirs and assigns, against the said party of the first part, its successors, and against all and every person or persons whomsoever lawfully claiming or to claim the same by, through and under the grantor herein, shall and will warrant and by these presents forever defend.
