LEASE

THIS LEASE, Made this 1 st day of March, A.D. 1933, BY AND BETWEEN, D. A. DORSEY and wife, herein called the Lessors and CHARLES GOLDSTEIN, herein called the Lessoe.

WITNESSETH, That in consideration of the covenants contained, on the part of the said Lessee to be kept and performed, the said Lesses do hereby lease to the said Lessee the following described property:

2nd Avenue, Miami, Florida.

YEARS, from the 1st day of April, of 1933, the said Lessee paying therefore the sum of Fifty (\$50.00) Dollars per month for the months of November, December, January, February, March and April, and the sum of THIRTY (\$30.00) DOLLARS per month for the months of May, June, July, August, September and October.

And the said Lesses covenants with the said Lessors to pay the said rent in advance on the first of each and every month for the said term, the first payment to be made on the 1st of April, A.D. 1933; to make no unlawful, improper or offensive use of the premises; not to assign this lease or to sublet any part of said premises without the written consent of the Lessors; not to use said premises for any other purpose than as a general haberdashery store, men's furnishings, hats, suits and shoes, and to quit and deliver up said premises at the end of said term in as good condition as they are now (ordinary wear and decay and damage by the elements only excepted). And the said Lessee hereby covenants and agrees that if default shall be for a period of 5 days, made in the payment of the rent as eforesaid or if the said Lessee shall violate any of the covenants of this lease, then said lessee shall become tenant at sufferance, hereby waiving all right of notice, and the Lessors shall be entitled immediately to re-enter and re-take possession of the demised premises.

It is understood that Lessors will not lesse to any other tenant in the building for the same line of goods handled by Lessee. This restriction on the part of the landlord shall not apply to any store which has any front on 10th Street, providing the said front is not closer than thirty feet from the corner of 2nd Avenue.
