In the meantime, we can now confirm, after many days of private research, that the presumed assassin of my Brother Georges, has been eliminated by members of his same group, a style well-known to the Armed MAFIA to skip away from any denunciation; this man known locally under the nickname of: "Ti BATEAU" literally "Small Boat", is no more but the ORDINANCE of the self proclaimed, now Chief of Police, Colonel of September 29/30, 1991.

To Whom it may Concern

This is A Resume of the SITUATION

- 1.- First of ALL, I must inform you of a terrible event that occurred here in HAITI : THE ASSASSINATION of MY BROTHER GEORGES.
- 2.- As you may have known, I AM personally involved strongly in Politics in my Country: HAITI; NOT AS A POLITICIAN, but working TO BRING ABOUT needed changes in the government, countering the CORRUPTED OLD STYLE IMPERIALIST SUPPORTED POLITICIANS by "CREATIONS", to open the way and move the majority of the population from their misery style of life to a more decent one.
- 3.- IN a PEACEFULL Revolution, a free election WAS WON in December 16, 1990, against, of course, the WILL of IMPERIALIST AMERICA.
- 4.- I WAS the FINANCIAL BACKER of the WINNER. And I do not look for ANY PERSONAL "POLITICAL POWER" or Interest or taking in ANY PROFITS.
- 5.- On SEPTEMBER 29/30, 1991, A SAVAGE and Bloody Coup d'Etat, orchestrated by the U.S.A. Ambassador to HAITI, himself an EXPERT in TERRORISM, Alvin P. Adams JR., brought to power A SO CALLED "MODERATE GENERAL" who does not even have a hold of the MILITARY hierarchy AND a self-proclaimed CHIEF of POLICE for the CAPITAL CITY, with the title of COLONEL.
- 6.- Since THEN, REPRESSION AGAINST the majority of the people who elected FATHER JEAN BERTRAND ARISTIDE by a LANDSLIDE, is all over the COUNTRY.
- 7.- My PRIVATE house WAS ATTACKED by the MILITARY as early as OCTOBER 1<sup>st</sup> 1991, i.e. the day after the COMPLETION of the Coup d'Etat.

8.- On October 15, 1991, I WAS ARRESTED at my Brother Georges' house by about 20 Soldiers and officers, half in military clothing, half in Civilians clothes, but all heavily armed.
- 9.- That night of October 15/16, at about ONE (1) A.M., Seven of those same men, entered my brother's house and armed with machine gun, Rifles and pistols, stole every things from Money, Jewelry and Appliances Radio T.V. etc and to SCARE Georges, shot twice behind his ears. Everyone in the house did recognize the same faces that were in the house earlier during my ARREST. Even then, while in jail, I mentionned this fact to Captain JoAnis who arrested me, and he AGREED that those thieves were of his military men under "his" command. Detained without charges for 11 (Eleven) days and then released without any further explanations, like why my house WAS ATTACKED : A grenade was thrown in the house and all the tiles of the front gallery were machin funned.
- 10.- I went back to work that same October 26, 1991, unscared by this mafia style organized Army, who clearly was proceeding for the complete MILITARY OCCUPATION of HAITI, with full control over DRUG TRAFFICKING, Smuggling of merchandise - from T.V. to CARS, cigarettes, spirits and foods, and ARM DEALINGS for their sole self interests, with the support of the United States of AMERICA Government and Administration, the local Oligarchy and World Imperialism.
- 11.- On April 4, 1992, my brother Georges' house WAS invaded by Policemen / Army personnel : one maid WAS ARRESTED without knowing why ; she WAS molested, beaten and released the same night

At the same time, another group of Policemen / Army personnel paid a remarked visit to my house where they found NO ONE.

- 12.- ON MAY 26, 1992 while leaving our business place at 6:00 P.M. after having completed a full day work, I move to my CAR parked just in front of the store and my brother Georges proceeded to his CAR across the street to the parking lot. Before he reached his CAR, he was funned down just 2 minutes after, a Bullet - American MADE - in the right shoulder, Two(2) others in the BACK. This happened in broad DAY light in front of hundreds of passersby and gallery/street vendors. Nearby, less than 300 foot (Three hundred foot) away is a well known police station "The Cafeteria". The assassins took refuge there before the police came to the site of the murder; Arriving family were not allowed to come near the scene where the Police wanted to make sure that Georges dies before he arrives at the MORGUE. We could not take the still living body to Bring him to A hospital. Georges was dumped in A GANGSTER'S TRUCK (The Anti-fang Army unit headed by the same but now MAJOR JOANIS.) No DOCTORS were ALLOWED at the MORGUE. And we had to get a lawier to be able to RECOVER only (3) Three days later, Georges ASSASSINATED BODY. The military still supported by the U.S.A. / Bush Administration said nothing. Up to this date we are unable to get a copy of the Autopsie Required by the court and the gangsters.

- 13.- At Georges funeral that, unscared, I had had sung at the CATHEDRAL of Port-Au-Prince, more than 700 hundred men with top rated communications system, heavily arms, motorcicles, pick-up trucks and with all the military equipment - All

U.S.A. and Israeli made - were at the scene. The "Tontons Macoutes" (Thugs men of the Duvalier regime) are back in military and plain clothes. After the funeral, the cortège proceeded slowly on foot to the cemetery. From a 400 followers crowd, we were only 7 (seven) of the immediate family to reach the cemetery. All others were either moved out of the cortège, forced to run out, beaten or arrested by the surrounding "Tontons Macoutes". Even our own business employees were beaten and arrested without any reason.

14.- THIS IS THE NEW WORLD ORDER THAT IMPERIALIST AMERICA IS PROMOTING. MILITARY ABOVE THE LAW WITH PUPPET CIVILIAN GOVERNMENT THAT ARE PUT IN POWER BY MILITARY FORCE, COUP D'ETAT IF NEEDS BE, WHERE ALL REPRESSION STYLES ARE GOOD FOR THEM TO MEET THEIR GOALS. THEIR GOALS? NO THEIR GOAL: CONTROLLED ABIDING GOVERNMENT AROUND THE WORLD TO U.S.A. CORRUPTED POWER WITH NO LIFE EVER TO RESISTING POPULATION, AND TO ACHIEVE THIS LATTER PART: DESTROY THE RESISTING COUNTRY ECONOMY. THE MAJORITY OF THE PEOPLE, USUALLY THE POOR, IS FIRST TO SUFFER, AS THE RICH CAN ALWAYS MINGLES WITH THE CORRUPTED GOVERNMENTS.

15.- I AM BACK IN THE BUSINESS, BUT WITH THE EMBARGO THERE IS NOT MUCH TO DO. ALSO THE ECONOMICAL SITUATION KEEPS WORSENING AND WITH THE HIGH COST OF FOREIGN EXCHANGE, BUSINESS ACTIVITY IS VERY SLOW. THE CONTINUING REPRESSION IS ADDING ALSO TO THE SLOWDOWN OF THE ECONOMY. I WILL ALSO CHANGE THE BUSINESS INTO A WHOLESALE/DISTRIBUTION FIRM WITH NO MORE RETAILING.

16.- THE ABOVE IS THE REALITY, UNLIVABLE REALITY. I WILL APPRECIATE YOU USING THESE INFORMATION TO BRING AWARENESS TO YOUR CHAMBER OF COMMERCE, YOUR CONGRESS / PARLIAMENT REPRESENTATIVE, YOUR GOVERNMENT, AS WELL AS THE PRESS AND PEOPLE OF YOUR COUNTRY TO HELP RESTORE DEMOCRATIC IN HAITI.
