Enclosing herewith, Rutherford Collier, Inc. bank statement for month of April, 1939. There has been no transaction since that time, so no other statements have been sent: I gave others to you before leaving this Spring, for the months dating from Aug. 1939 to April, 1939.

Unless there is another income tax payment due this month, there will be no other transaction up to July 31st that I anticipate.

The credit shown on bank statement April 17th, is presumed to correct error in interest credit, on Rutherford Collier, Inc. notes which the bank holds for collection. Perhaps, I have figured wrong, but believe there is still an error of a few dollars in this account.

The notes held by the bank given by the Triess Corp. on the Lincoln Road property, totaled, originally, \$60,000.00, less \$3,000.00 deducted for commission, from the first three notes; leaving \$57,000.00. Against that, \$57,000.00, I have borrowed a total sum of \$42,500.00; leaving me an equity of \$14,500.00. Six months interest on \$14,500.00 would be \$435.00. The transaction shown on April 4th, on bank statement, credits Rutherford Collier, Inc with \$159.50; this, with the credit of \$237.00 of April 17th, makes a total interest credit of \$396.50, leaving a difference of \$39.00, according to my figures. The collection charge should not be that much, should it?

Hope you are all having a pleasant summer. Weather good here, but business bad.
