I was only interested in the parent company here at Miami with Mr. Ourtiss on aerocars. The Briggs Company was operating under a license.

Dear Margaret :-

I have yours of May 31st. I suppose by this time you have received my supplementary letter about the aerocar - that if we could rent it for four months and get an agreement that they would protect us on the care of the car, it might be well to do it.

There still must be somebody, however, to buy the car, if we could only locate the right person - some hotel or golf club that would want a car of this kind.

We can get all three of us through with the car on the train for \$218.79. Our meals will be extra, of course. We cannot drive through and pay hotel expenses, etc., for less than about \$200.00, and then we would have about 1500 miles extra wear and tear on the car - and that isn't so good, and I don't care to drive through. It is dabgerous to drive on the roads nowadays, and I don't care to get up early in the morning, and if I don't get up early and we do not drive at night, it will take about five days to make the trip - and it is a d-- nuisance.

If we come by train, the car will arrive in good shape, and with other car fixed up as an auxiliary, we will have all the cars we need for the short time we will be there.

This Hudson here is in pretty good shape and you certainly couldn't buy another car for \$250.00 as good, and I think you can sell it in the fall better than you could now, and with the \$250.00 on the old Essex', we would have about \$500.00 to start on.

I do not think it is at all safe for you to drive over the roads nowadays, with traffic conditions as they are, as you are quite liable to get into an accident that would cost perhaps \$2,000 or \$3,000 to get out of, and you are liable to get into an accident with people who are totally irresponsible themselves and yet they can always get a lawyer to sue somebody who is responsible.

We are making a crate for the dogs to go up to Ohio today. I hate to see them go. They really are causing no trouble at all — they stay in the yard and we are having a lot of fun with them. They have a lot of grit — you can pick them up by the tail, neck, nose, or any place, and they will never yap. Also they play like I have never seen pups play before, and they are at it from morning until night.

I am sorry to hear regarding your mother.

I don't expect to be able to get away from here until some time after the 15th.

P.S.-- Just saw wire regarding furniture in the No. 7 house at Bayview Golony.

I don't know what in h--- you want to do with it. It would cost a lot to ship it any place and, besides, you have a lot of furniture and the garage here is full of furniture, which of course I will empty out as soon as I get my little house built. I cannot have an upkeep on this property of more than \$400 for the year, outside of taxes. I think the property should rent for \$1500 without any trouble.

From what I hear about sales down in Long Island, they are still very dead, and I would much rather myself have money invested here at the Beach.

I am sorry you did not send more particulars regarding negotiations you have as to No. 7 house. From what I see of things, you would have a tough time to rent it for \$1,000 for the summer, and certainly couldn't get over \$1200 a year if somebody wanted to rent it for the year round; which is no return at all on a \$10,000 investment for a house and furniture, and with two or three kids in the house they would kick the furniture all to pieces; so I think you had better watch your step rather carefully.

Dear Margaret:-

When you are speaking about an investment, I think if you can dispose of your Lincoln Road property and some of your other property at this time, it would be very well to do so.

It is hard to say, but there may be quite a surplus of shops on Lincoln Road this next season. I think I have told you that there had been five failures on Lincoln Road of the smaller shops, and there is practically no demand for new rentals for next year, in spite of the splendid season that some of the shops have had this year.

Now, in a meeting just the other day, the big lot just north of the Flamingo was rather hastily appraised at \$20,000. This lot will hold 20 cottages, and at a rental of \$1600 apiece, these cottages should show somewhere around 18 to 22% gross profit, from which the taxes and upkeep of the grounds generally will have to be deducted.

The Flamingo this year made \$61,000 more than the Nautilus, in spite of the fact that the Nautilus is much larger and has more facilities in every way.

With these rental cottages right near the center of activities and with the select clientele, which would most be handled by the Flamingo Company, they should become very popular; and these cottages can be built complete for \$6,000 apiece - all concrete and fireproof, like the Kiser house - eliminating insurance - and with facilities at small dues to use the swimming pool at the Flamingo and access to the tennis courts, etc.

I have been satisfied that this is one of the best investments that could be made at Miami Beach at this time. There is a complete rock wall around the property, and if cleaned up and planted, it would make a perfectly beautiful subdivision.

Of course, it is not necessary to build the 20 cottages at once; but there is one thing certain: That you are making a big mistake in not getting some income-producing property. With my salary, I cannot lay up enough money to even bury me, if I should happen to die next month.

About a \$7,000 house on your lot, with the dock, would offer a very fine rental property, or a place to live and allow you to sell the Alton Road property.

The lack of sale of the Lincoln Road property has cost you in

the past two years an income of at least \$12,000, and perhaps \$14,000, including taxes.

I don't know what your negotiations are at Port Washington, but I do know you are buying a sick dog, unless you have a sale for the property, which I certainly doubt very much; and while the property may seem cheap, it isn't cheap unless you can get an income from it of something like 10% or 12% net, which is necessary on rental property.

Right now, if you analyze the situation, you are property poor, and the taxes are slowly eating into you, and if anything should happen to me, you would be in a "hell-of-a" fix, unless you immediately disposed of some of your properties.

Everything is going here apparently bigger than ever. You have to give two weeks' notice now to get any blocks at all for building a house, and one week's notice to get any sand.

I wrote you about closing up the house here. We can do it, and there is no necessity for you to come down here and spend a couple of hundred dollars, unless you have something important to attend to that I do not know anything about.

There are quite a number of the larger houses that are being carried over for next season - two on Alton Road that have been built for two years that have not been sold; of course, though, these are houses that run into considerable money and where the contractor expects to hang on until he can make a very good profit.

The demand for the smaller houses is spreading all over the north part of the Beach, and you would be surprised to see the amount of building up there in \$5,000, \$6,000 and \$7,000 houses. It is really tremendous; also in the northern part of Miami proper.

We have been having some very good weather, but it getting hot -- about 82. We have had quite a little rain and naturally we have some mosquitoes, and will probably have a lot more in another week or two.

I will have all the drawings of the little house that I am going to build wodn in the Flamingo Terrace Subdivision, and I will bring them up North with me. I expect to get a loan from the Government, unless they run out of money before next week.

The pups went North last night, and Dotty Adams came over and got her two. She is delighted with them. I hated to see them go. Of course we don't want five dogs around the place, but I would rather give up a couple of bottles of beer a day to feed those pups than anything I know of.

The awnings up at the house are in very bad shape, and I think

we should take them down and store them, and if you want to use them next year, you will have to have them painted, as they look like the very devil now. They must have been unusually poor material to go to pieces so quickly.

I am making you a memorandum of some of the checks in the last few days, just to give you an idea of what goes with a fairly respectable salary under our present operations.

I will not get all of the money at present, but I think that is alright. I think it will be a fine thing for the company to have it and of course, I am delighted to have it out of our way.

If you cannot drive through for less than \$200.00, then it surely would be best for you to come by train. ... now, if you knew as much about economising in travelling as you do about closing houses, you might get here intact for considerably less than \$200.00. I brought two cars. four people, baggage, Mitzi and paid \$7.00 or \$8.00 repairs... all for \$97.00 or eight dollars... that included meals too .... two or three years ago .... and for amusement, had some rather funny experiences, which were really no part of my planning. Anyway, you should come the way you think most comfortable and convenient ... as for me, I'll take the highway from here to Florida most all the time, if I have a good car to go thru with. I would hesitate a bit to start out Essie on a long jaunt.... in fact, I had some misgivings about going to East Hampton the other day, but I did, and nothing happened; I mean to say Essie behaved almost perfectly. I'm still getting a new piece almost every day, but none of it is expensive and it will do alright for a second car here. I think the Hudson will bring \$250.00 this Fall.

I'm glad I was not there to see the puppies leave... but I'm sure they will all have good homes. Tuma's are quite disappointed they did not get one. Harlacs, who lived here last year, have a new bayy... someone was teasing the little boy by asking if they could not take him home and he said "No. you can't take him... but I'm going back to the hospital and get about a thousand more.. everyone who sees him wants one"....

King ate a little bit this evening, but he still refuses to make up with us or come up to the house; if I go down there he comes up here... he wags his tail, but won't let me touch him... I leave food out up here but he won't eat here either... and I've tried everything from soup to ice cream....

Dear Margaret:-

I have yours of the 18th. The Lincoln Hotel is all torn up; they have had to put a new roof over half of it - I refer to the Cottage. I have one room and Emma has a small room; Humpage will soon be back and so will Plinn. I can only figure on staying at the Lincoln myself a very limited time as the general conditions there are not suitable for my various troubles.

We certainly have no room for chauffers and if you are figuring on Garrett coming down here with you, do not figure on the Lincoln at all; just figure on opening up your garage apartment and getting along the best you can there. Emma is going to leave as soon as she can and get her the cottage in the Catskills which you know she has been talking about, and in the meantime it is going to be necessary for me to get somebody who can look after my insulin treatments, drive me around and look after my clothes. Besides that I am getting along very well with little work, and under no circumstances would I get mixed up with a shut house, boarding house idea such as we had all this last summer.

Fred Bennett is sick and so is his wife, and in the meantime the caretaker at the Lincoln has been in an automobile accident and is hardly able to walk. As usual they tore the Cottage all up in packing things away and it looks like a mess, and it is one of the most silliest things I have ever heard of and it will not happen again as long as I am in the Hotel. It will take a lot of hard work to get it back in shape. Everything was torn up and wrapped up so that no one can find anything, and when you do find it, you do not know where it belongs and it is a job to do all over again, but as I said, it will never happen again at the Cottage as long as I have anything to do with the Hotel. This thing of packing everything away for about three or four months closing is perfectly ridiculous. Naturally, I am irritated at the present condition of the Cottage and the caretaker is such a damn dumb-bell that you can not even find the keys so that you can lock the house up, and I expect you will find about the same condition when you get down here at your house, but you can come into the Lincoln for a few days until you can get your garage apartment in shape to move into, but under no circumstances whatever can we undertake to take care of any chauffers or any other help, at the Lincoln. We have all on our hands that we can take care of now.

The woman that you engaged and was supposed to be here Sunday has not shown up yet, so that is up to you. I told Lee that Barney could get competent help to open up the house. It has been terribly hot here for the last few days, but yesterday and today it is wonderful and I believe out hot spell is over.

I don't know that you have a correct picture of this situation down here. Houses are being rented very fast and Barney Lundberg picked up the other day the best bargain I know of on the Beach, at 51st St. and Indian Creek. He is going to have something there to rent some rooms, but there is very little furniture so I told him I would put my furniture in there, which will help clean up the garage and at least take care of the furniture.

It will be impossible for us to stay at the Lincoln except until about October first, or perhaps a few days after that, as these rooms will be taken up by regular customers at ten or twelve dollars a day which, of course, I do not care to pay.
