



#### Physical description:

Structure is a two-story Mission style residence located in an area that was developed before the neighborhood became part of Miami Shores. The structure has a two-story W mass and a single-story E mass. Significant features include an entry portico with buttress walls and gable roof with parapet; cast masonry shields on the front (S) facades, and a flat roof with parapet alternating with barrel tile coping. A two-story detached garage in the rear (N) is of similar design and construction. Another single-story wing extends to the rear (N) of the two-story mass.
