

CRANT STOCKDALE, our newest legislator, recently assured Att'y Abe Aronovitz by letter-and sealed it with his signature—that he would support the increase in Miami city commissioners' salaries to \$5,000. In addition to that-just five minutes before this week's joint meeting between the city commission and the Dade county legislative bloc-Stockdale assured Roy Singer, representing Labor, that he was for the raise.

State Senator Gautier, however, browbeat the Dade legislative group, including Stockdale, into refusing to go along with the proposed raise.

Gautier made a counter proposition. IF the city commission would sponsor consolidation of city and county tax departments, then he would vote for the increase in salaries.

Doesn't that practically amount to bribery or coercion, or both?

It's certainly foreign to the nature of any redblooded man.


Power Lobby, Gannett Lobby, Use New Bogey

On the day the McGraw Hill ad appeared, magazines carried full page ads from Purcell L. Smith, the \$65,000a-year lobbyist for private utility interests. His message, "An Open Letter to Mr. and Mrs. America," declared that "recent years have brought a tremendous acceleration of the pace of bit-by-bit socialism in America."


On the same day in Congress, Rep. Ralph E. Church inserted a speech by DeWitt Emery headed: "Our Socialistic Trends." Appearing on page A-941 of the Feb. 17 CR, it began: "Mr. Speaker, under leave to extend my remarks in the Record, I included the following speech en titled, "Creeping Paralysis," made by DeWitt Emery, president of the National Small Business Men's Ass'n . . 
The Gannett committee postcard campaign outlines a full course of action to kill all pending legislation, and even gets in its customary attack on "labor bosses." It reads, in part:

"There," says Rogers, "she lies starving and writhing miserably-in HER 'PIT'!"

### And Here's What They Do **To Criminally Insane!**

▲ NOTHER case that forced itself on Roger's attention P. was that of a criminally insane patient who had been strapped, hands and feet, to his bed for four or five days before Rogers started to work at the Retreat.

"He's a murderer, yes," Rogers wrote in his notes. "But how can anyone stand by and see a man mentally affected as he lie in his own stool and urine day after day?

"This patient is dangerous, yes.

"But is that a valid reason for a hospital to refuse to let him go to the toilet, after taking all proper precautions, of course?

"I released his feet, leaving on his handcuffs. And I permitted him to use the toilet and get some exercise.

"He complains of his head hurting him. And I am convinced of the truth of his complaint, because his nose bleeds profusely at times.

But Twas Only A Gag, Wasn't It?

TACK KOFOED devoted some of his column to lamenting the fact that some comedians receive huge salareis and that professors at the University of Florida make so little. He goes on space-filling to report that more than a dozen nightclub performers got more than that each week for six or seven hours work in local night clubs during the season. He opines (also with the air of saying something original) that education is much more important than the telling of funny stories. He adds: "If financial returns are any indication, Americans apparently don't believe it to be true."




