"Dr. John Abercrombie and family came to this section in 1883 and located on land that is now the 'Moss Ridge Grove' of Joseph Sibley. He built a very large and comfortable residence amid beautiful surroundings, cleared and fenced several acres and set out fruit trees of various kinds. In the meantime, he practiced medicine, going wherever sickness called him—though the point was then, as now, eminently healthy, and very few except children could really spare time to get sick. He was known throughout the section as the family doctor, which term was very appropriately applied, as at the time he was the only physician in the peninsula. Dr. John is one of the kindest, most free

He came here from Natchez, Miss., in 1883 and settled on the rich hammock land north of Lake Maggiore. He donated land for St. Bartholomew's Church, the first church on the lower peninsula and for the church cemetery, both on Lakeview Avenue. He died January 22, 1912.

Hentz doesn't indicate whether Abernathy was an M.D. or possibly a dentist, but since Hentz did several dental procedures during his stay at Quincy, I suspect there were no dentists in Quincy at that time.

He has been a business man and a practitioner in St. Augustine for ten years. His drug-store is conspicuously situated opposite the Plaza, and it has a complete stock of drugs, fancy articles, and mineral-waters, and is one of the principal headquarters for the tourists who are at the hotels. He has three clerks in the drug-store, Messrs. J.D. Lopez, Eugene Sugué, and C.A. Lopez. Mr. J.D. Lopez has a diploma from the Medical College of Savannah, Ga.; Mr. Eugene Sugué is also a practical druggist, as is Mr. C.A. Lopez. Dr. Alba is a native of Williamsport, Pa., and was elected Mayor of St. Augustine, November, 1883.

Dr. Andrew Anderson, a practicing physician, was born in St. Augustine, March 13, 1839, and died there on December 1, 1923. His parents had moved to St. Augustine from New England several years before his birth. He graduated from Princeton in 1861 and from The College of Physicians and Surgeons, New York City, in 1865. He returned to St. Augustine to practice.

Dr. Anderson persuaded Henry M. Flagler to invest in Florida, and became his agent in St. ~~S~~ugustine.

When Flagler feared that the digging of the foundation for the Ponce de Leon Hotel might create a malarial epidemic in St. Augustine, Dr. Anderson assured him

reference in the master file dated 1830.
