An excellent account of the Burnsed Act of 1983 and its sequellum, the Health Care Access Act of 1984, which have enabled the county health units to establish outpatient clinics of the general practice or family practice type to care for the medically indigent - non-medicare and Medicaid for the most part. These are open to the general public but it is anticipated that paying patients will prefer other delivery systems. These clinics can buy services from private practitioners and hospitals altho they do not pay "top dollar."
