BIG FISH, LITTIE FISH

THE DEVIL'S ADVOCATE

Play-goers who plan to see BIG FISH, LITTIE FISH for any other reason than to enjoy fine acting are apt to be disappointed. A rec ent newspaper interview of one of the stars of the show would tend to intrigue seekers of the homosexual theme. Even though the actor tried to mininize the homosexual aspect, enough was indicated in the interview to mislead those who are over-eager. A viewing of the play in Philadelphia proved that whatever homophile aspect existed could have passed unnoticed to the unwary. The plot itself is very thin and ofttimes implausible -and only the excellent characterizations and the competent portrayals might serve to recommend this new play.

More satisfactory and to the point is THE DEVIL'S ADVOCATE, opening in New York in early March. Adapted by Dore Schary from Morris West's novel of the same name, this play has homosexual aspects which are overt and important. The fine plot and excellent acting put THE DEVIL'S ADVOCATE on the recommended list.

## The "Primeval Forest"

is so nicknamed because, though small in area, it has been undisturbed for more than 300 years. This unique spot of true wilderness in our big-cities chain is preserved intact by Rutgers University which now owns it, for long-range study of the effects the animals and plant life have on each other when left entirely alone. For example, a fallen tree is never removed--instead, observation shows what interesting fungi and insects move in to disintegrate the log and how long it takes them! The Forest is not a tangle of thick growth as many people expect. How the trees provide their own breathing space is one of the things entertainingly explained by a Rutgers University professor who conducts the easy hour-long tour of the Forest.

We will first eat our sandwich lunches on the banks of the old Millstone River Canal, after a short walk on the pleasant towpath. Comfortable clothes and sneakers are recommended; besides your lunch you may want to bring field glasses and a camera.
