

Dear Mrs. Helene:

In July, after many months of evaluating alternative methods and soliciting input from groups which could be affected by our decision, this agency decided to initiate a chemical treatment program for the Arch Creek Canal. The program was designed to bring nuisance weeds such as alligator weed, torpedo grass and duckweed, more commonly referred to as "green slime", under control. Previously, these weeds invaded the creek causing an unsightly mess, which has been the subject of numerous complaints to our staff.

The initial treatment applied to the torpedo grass and alligator weed has been successful. It is now time to move into the second phase of treatment which is designed to eliminate the existing growth of duckweed.

To do this we will proceed as before; the canal will be treated in phases. However, duckweed does not occur in every reach of the canal nor in the same concentration in all areas. Therefore, a detailed treatment schedule is difficult to outline. It should be noted that depending on the infestation level on the day of treatment, a particular phase or reach may be treated consecutively, however, no more than one-third of the canal will be treated on a given day. Because of such influences as the tide, wind, and the operation of the canal for flood protection, the concentration of duckweed may shift from reach to reach, thus the need for the flexibility in the treatment schedule.

In accordance with the maintenance and operational responsibilities for the waterway and to gain control over the duckweed, as quickly as possible, the staff of this agency has designed a general treatment outline. The canal will be treated in reaches (phases) beginning the week of September 26 and continuing through October and November until a significant decrease in the concentration of the duckweed is achieved. The canal will be posted the day of treatment and each condominium association and single-family residence adjacent to the treated area of the canal will receive an additional notice on the day of treatment.

Once the aquatic weeds have been reduced to a manageable level this area will be placed on a routine maintenance schedule and you will receive treatment notices and the canal will be posted on the day of treatment.
