

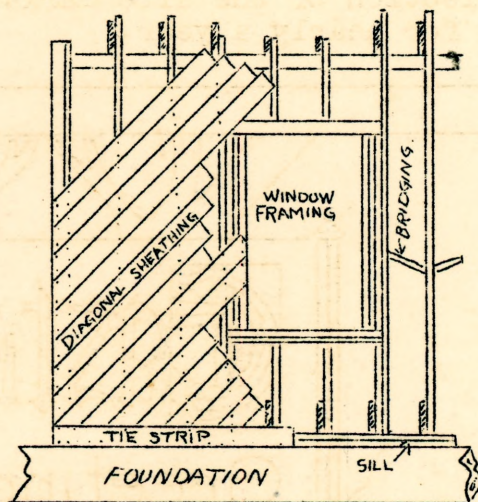
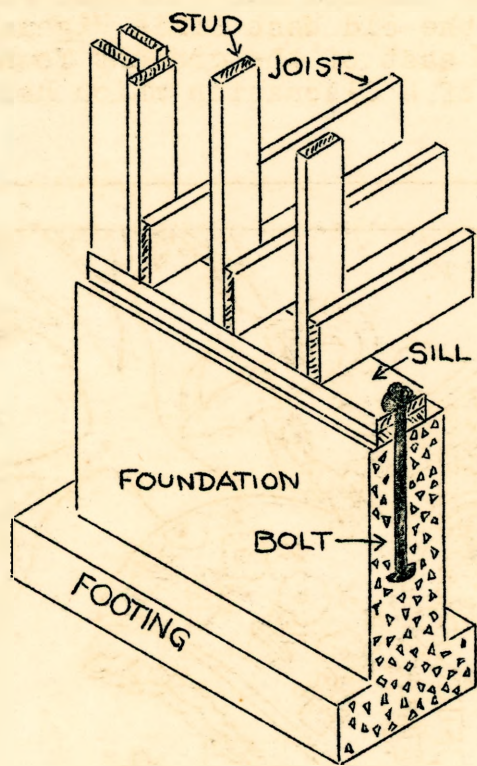

## DEEDS FOR TOWN HALL SITE OBTAINED GRIBBLE'S SUBDIVISION LOCATION CHOSEN

The new Town Hall will be built on lots three and four of Gribble's subdivision, it was announced at the Town Hall last week. An unconditional warranty deed to lot three, signed by R. L. Gribble and Susan E. Gribble, and a similar deed to lot four, signed by the Baker-Riddle Company, were obtained and placed on record in the office of the Clerk of the Circuit Court of Dade County. The lots are each fifty feet front by one hundred and thirteen feet deep. The site is on the south side of the old West Dixie Highway, 105 feet west of Avenue "D" and 275 feet east of the present Town Hall. The selection of the site marks the end of a discussion which has lasted for nearly a year.

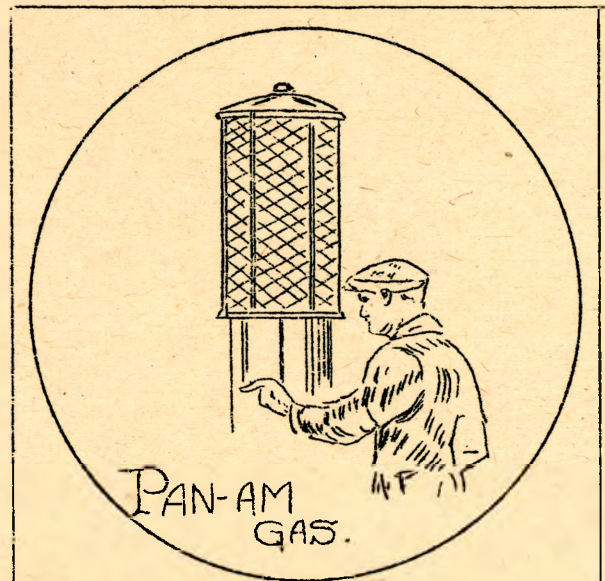


At the first meeting of the Town Council after the bond election in November, at which the municipal building was authorized by the voters, the Council decided that a Committee of three members should be appointed for the purpose of considering the various proposed sites for the Town Hall.

Mr. Morgan, President of the Council, appointed, as members of this Committee, Mr. J.B. Jeffries, representing the Eastern part of the Town, Mr. R.L. Gribble, representing the Central section, and Mr. Arthur M. Griffing, representative of the Western section.

This Committee gave careful consideration to all sites offered, and finally, on March 14, presented their report recommending that lots three and four of Gribble's Sub-division be selected. The Committee reported that the owners of this property had offered to donate to the Town 80 front feet, and the committee believed that the owners would be willing to donate the additional 20 feet. The committee report was unanimous, and the Town Council decided that the location proposed by the Committee should be accepted, with the proviso that all of lots three and four (having an aggregate frontage of 100 feet) should be deeded to the Town of Miami Shores free and clear of any encumbrances. It is noteworthy that the vote of the Council on this matter was unanimous and that every member of the Council was present at the meeting.

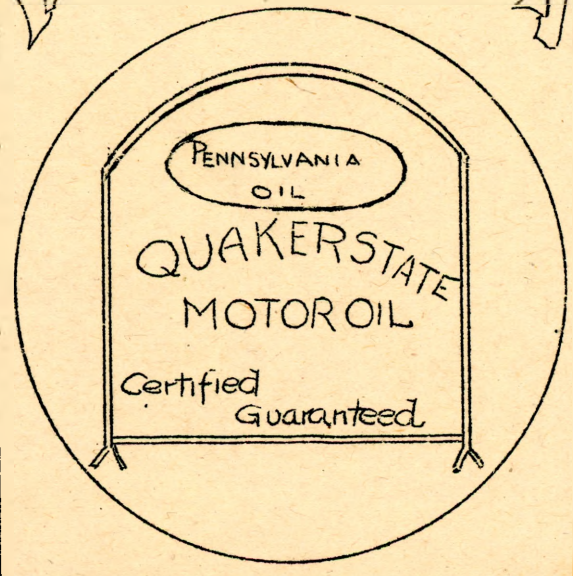
At the Council meeting last Monday a petition was presented, bearing a number of signatures, requesting that the Council reconsider the matter and select a different location. Upon checking the petition, however, it was found to contain the signatures of only forty out of the three hundred and twenty registered voters of the Town. All citizens of the Town objecting to the site selected were invited by Mr. Morgan, President of the

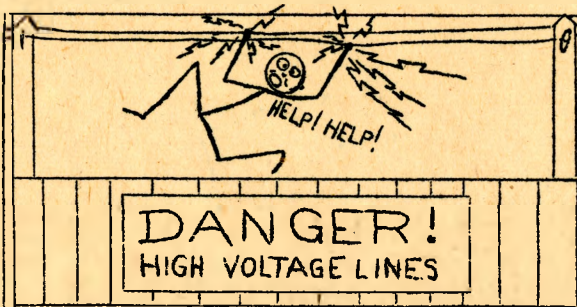

Council, to present their views for the consideration of the Council and Mr. Arthur H. Wagener spoke in favor of a reconsideration of the site. No other objection was voiced, however, and the Council decided, by unanimous vote, to adhere to its action taken previously.

MOSQUITO CONTROL DEPARTMENT CREATED  
L. H. Browning appointed Director.

At the Council meeting last Monday, the establishment of a Department of Mosquito Control was authorized, to carry out the program approved by the voters of the town at the November election. The movement for mosquito control action in the Town of Miami Shores was begun in August of last year. Mosquito control experts were sent by the State Board of Health at the request of the Town authorities, for the purpose of making a thorough study of the mosquito situation

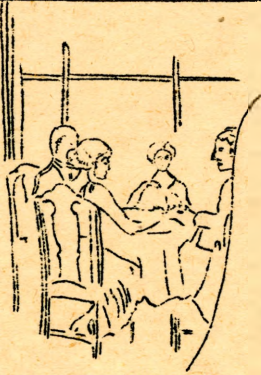

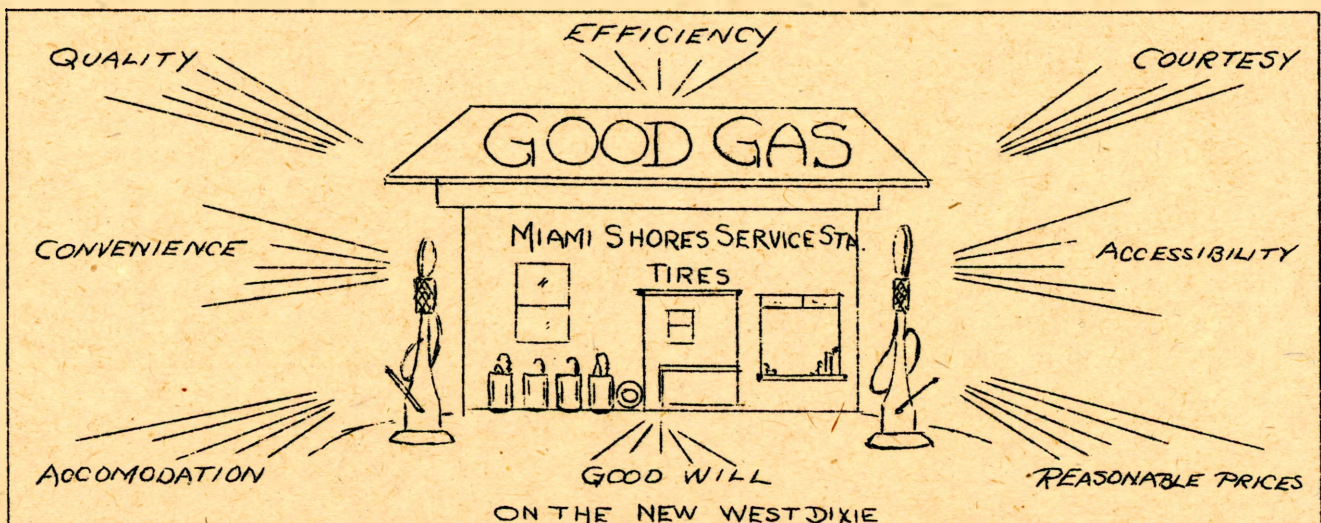
ance calling the bond election, proposed an item of Five Thousand Dollars for mosquito control. This item was approved by the voters, seventy seven ballots being cast in favor of the proposal and eleven votes against.

At the Council meeting two weeks ago it was voted to request the State Board of Health to give further advice to the Town Council on the best method of spending the \$5000.00 secured from the sale of the bonds, in order to give the greatest possible improvement in conditions. Pursuant to this request of the Council, Messrs. Broughman and Marner again came to Miami Shores and made further investigation. Their report was presented to the Council last Monday and the Council, in accordance with their recommendations, created a Department of Mosquito Control.

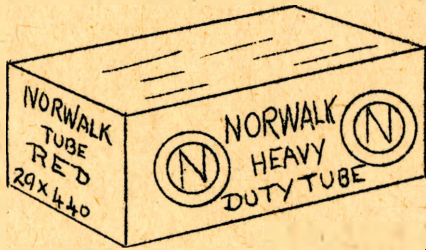

## SHAPPELL NAMED TOWN HALL ARCHITECT

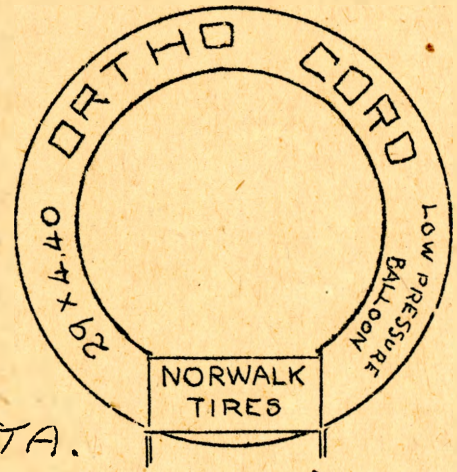

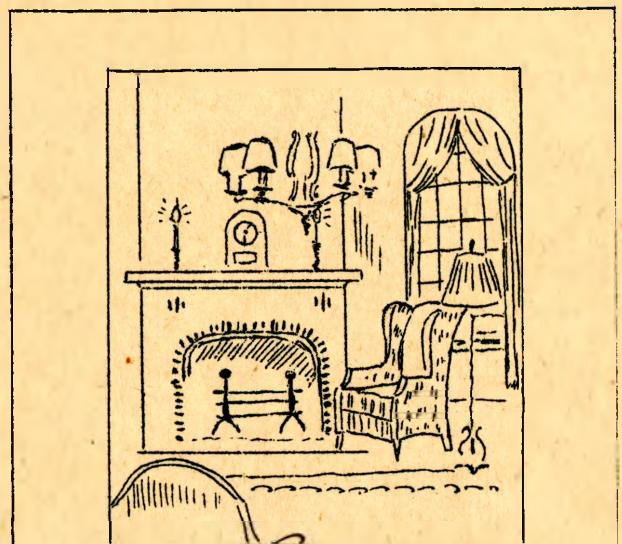

PARKING ORDINANCE PASSED


The Town Council, last Monday, passed an ordinance which was approved by Mayor Brion, providing for parking lines to be painted along the highways of the



Mayor W. P. Brion stated when interviewed at the Town Hall last Wednesday. "Many people are evidently under the impression", continued Mayor Brion, in response to an inquiry of a reporter from the Miami Shores Bulletin, "that all the tax payers of the Town are required to pay part of the cost of the street and sidewalk improvement program. This belief is erroneous" stated Mayor Brion. "When petitions are presented, requesting street or sidewalk improvements, the Council investigates, and if it finds that public sentiment in the area affected is favorable to the proposed improvement, a Resolution is passed ordering that the work be done, and that the entire cost be assessed against the lots and lands adjoining and contiguous, or bounding and abutting upon such improvement'." "Bonds are then issued in the amount of 70% of the estimated cost of the improvement and after completion of the work, and its final acceptance by the Town Council, further bonds are then issued for the entire balance of the actual cost".

"Included in the cost are the engineering fees, costs of advertising and all other expenses connected with the improvement. The assessments become liens against the property benefited and such assessments are payable one tenth each year over a period of ten years. The method of payment of the assessments corresponds with the maturities of the bonds issued to cover the cost. It will thus be seen," continued Mayor Brion, "that while the whole Town is interested indirectly in such improvements being made, that the entire cost is borne by the adjoining property owners directly affected.



"The policy of the Council", concluded Mayor Brion, "has been to grant all such petitions where it has appeared that the citizens and property owners directly affected were in favor of the proposed improvement program".
