CHANGE IN FEDERAL WITHHOLDING TAX - The Tax Reduction and Simplification Act of 1977 changed the standard deduction to a flat rate of \$2,200 for single individuals and \$3,200 for married couples filing joint returns. Since these changes affect the amount of income tax that will be withheld from employee wages paid after May 31, 1977, the With-holding Tax amount on your June 17th paycheck stub was slightly different from your last pay period. The amount withheld was calculated by the State Comptrol-ler's office based on the W-4 form currently on file for you. Since this new deduction scale may result in too little tax being withheld for married couples where both spouses are employed, you may wish to file a new W-4 card claiming fewer withholding allowances. of Circular C (Supplement) Employer's Tax Guide are available at the local IRS office to help you compute your correct tax. Safety Corner

Too much summer fun in the sun can cause sunburn, sun poisoning, prematurely aging skin and skin cancer. "Sense in the Sun", a booklet detailing how to play it safe during the summer months can be obtained without charge by dropping a postcard to the American Cancer Society, 1825 Connecticut Ave., N.W., Washington, D.C. 20009. They suggest you protect yourself by doing the following: 1) Do your sunning before 10 AM and after 3 PM to avoid the sun's strongest ultraviolet rays; limit exposure to the sun between these hours to 15 mins. 2) Use sunscreen preparations containing PABA (para-aminobenzoic acid); these will permit gradual tanning while protecting your skin from ultraviolet rays. 3) Don't count on the shade of a beach umbrella for complete protection; reflected sunlight can give a nasty burn.
4) Notify your physician if you notice any signs of skin cancer: a sore that does not heal, a change in size or color of a wart or mole; and the development of any unusual pigmented area on any part of the body.

Thus, as you or your spouse approaches age 65, you should apply for full coverage under the Supplemental Medicare Program by completing a Health Benefits Change Card in the Personnel Office to change your coverage.
