MORE SOCIAL SECURITY INFORMATION

Work after Retirement--There is a limit on the amount of money you can earn and still collect Social Security benefits. For 1977, if you earn more than \$3,000 in the year, \$1 in benefits is withheld for each \$2 you earn over \$3,000. If you receive retirement benefits, your earnings may affect yours and your dependent's benefits. If a dependent works, his/her earnings will affect only his/her benefits.

Social Security Disability Benefits-If you should become severely disabled, you can start drawing monthly Social Security benefits (after a 5-month waiting period) just as if you had reached retirement age. Your dependents can also draw benefits on the same basis as a retired employee's.

To be eligible you need medical proof showing you are unable to do any sort of substantial work for pay because of physical or mental disability, and this disability has lasted, or can be expected to last, not less than 12 months. Also, you must be "fully insured" and have had five years (20 quarters) of coverage in the last ten years prior to your disability. A worker who

MORE SOCIAL SECURITY INFO (Cont.)

Social Security Disability Benefits-becomes disabled between 24 and 31 can qualify for disability benefits if he/she worked in one half of the quarters between the time he/she is 21 and the time he/she is disabled. A person disabled before age 24 is eligible if he/she worked six quarters of the last 12. (There are special rules for disabled blind people.)

The amount of your monthly disability benefit is the same as the amount of the retirement benefit you would get if you were already 65.

Cost-of-Living Adjustments-In June of each year, all benefits will be subject to adjustments to keep them in line with living costs. If If the government's Consumer Price Index rises 3% or more between the first quarter of the preceding year and the first quarter of the current year, all benefits are increased by the same percentage in June of the current year. However, if a general increase is enacted by Congress in any year, or if such an increase becomes effective for any year, there can be no cost-ofliving adjustment for the next year.
