CREDIT UNION DROPS LOAN RATES

Effective immediately, personal loans, new auto loans and signature loans are all available at lower rates from the Credit Union. Also 60 month financing for new autos is now being offered. The auto rates are only guaranteed through June 30, 1986. New auto loans are now at 9.9% for as long as 48 months. Sixty month financing can now be obtained at only 10.9%. Used autos can be financed at 11.9%. These rates apply when you purchase your car. Personal loans were cut to 13% interest rate. You can refinance your old personal loan down to 13% without borrowing any additional money. However, the Credit Union suggests you seriously consider using this loan to pay off more expensive credit and charge cards, most of which are still at 18% to 20%. All permanent employees of FIU are eligible for membership in the Credit Union. For more information about the Credit Union or these loan rates, please contact Toby Disbrow. DRIVERS CAN RENEW LICENSES BY MAIL

Motorists who wait until the last minute to renew their driver licenses can do so by mail if they qualify as "safe drivers". As long as the envelope is postmarked before the license expires, safe drivers can get a four-year renewal by mail. Even if the expiration date has passed, a safe

driver can renew by mail within 60 days by enclosing a \$1 late fee. A safe driver is defined as a motorist who has not had a traffic ticket violation for at least three years. State law allows safe drivers to keep using their old license while renewals are being processed as long as they also keep the tear-off stub from renewal notices, which are mailed to drivers about 30 days before the licenses are scheduled to expire.
