# NETWORK '86

Starting June 15, 1986, the Metro-Dade Transportation Administration (MDTA) will make a series of transportation service changes that will affect every individual in Dade County using Metrobus, Metrorail or Metromover services. The changes are designed to provide every rider with a more reliable, simpler to use, and faster transit system. After much review and many hearings, the revisions are expected to remain in place for the next two years. The implementation of Network '86 involves every bus route in Dade County, including changes in schedules and route numbers and/or route letters. To help riders understand this new system, MDTA has established a Network '86 Telephone Hotline (637-5600) that will remain in operation until the end of June to answer questions regarding the new changes. Additionally, new publications will be available to assist you when using the new system. A "Network '86 Passenger Information Kit" (which contains Network '86 Passenger Information Guide, new system maps, and individual route guides which explain how each route will be affected) is ready. To request one of these kits, you may call the Network '86 Hotline and ask to receive a "Network '86 Passenger Information Kit" via U.S. mail. Remember, changes occur to the transit system on June 15, 1986.

#### April Open Enrollment for the Sick Leave Pool was a Tremendous Success

During April, 146 employees joined the Sick Leave Pool, bringing the total membership to 522. We welcome these new members. This enrollment adds 1,168 sick leave hours to the Pool balance. During the first year of the Sick Leave Pool, 569.75 hours were approved for use

by members. The current Pool balance is 3,606.25 hours.

The appointments for three of the current Sick Leave Pool Committee members expire on June 30, 1986. During the Semi-Annual meeting of Pool members, Marilyn Ochipa, the Career Service representative, was reappointed to serve another year. We appreciate the work and assistance provided by the total committee during the first year of the Sick Leave Pool Program, and commend Robert Merkel, the Faculty representative, and Rose Watson, the A&P representative, for the service they provided during their first year of membership.

The newly appointed Committee members are Joseph Gregg, Assistant Professor, Hospitality Management and Ana Sarasti, Director, Financial Aid. They will join Ms. Ochipa, Doris Bass, Bruce Hauptli, and Pat Duguid as committee members on July 1, 1986. Steve Belcher of the Division of Human Resources will continue to serve as the Pool Administrator.

# OPS To Be Covered by Medicare Portion of Social Security Tax

Effective April 1, 1986, OPS employees are now taxed 1.45% of their gross earning to cover the Medicare portion of the Social Security Tax. The following employees are excluded from this tax, by federal law:

- 1. F-1 and J-1 Visa holders, when the services performed carry out the purpose as specified by the F or J Visa status.
- 2. A student who is enrolled and regularly attending classes at the university employing him/her.

Employees who fall in the above categories <u>must</u> bring to the Office of Personnel Relations proof of FIU registration and/or a copy of current F-1 or J-1 Visa immediately, or

social security tax deduction will be made automatically.

You now have the opportunity to join in the 1986 U.S. Savings Bond Campaign. The '86 campaign will be conducted during the months of June and July. The current six-month rate on Savings Bonds is 8.36%.
