## 27 PAY DAYS IN 1987; 26 IN 1988:

Employees who are having Tax Sheltered Annuity or Deferred Compensation deductions should be aware that calendar year 1987 has 27 biweekly pay dates, and that calendar year 1988 will have 26 pay dates. You must take these differences into account when calculating your maximum tax-deferred contribution limits for both years.

Contact your company representative for necessary or desired action for 1987, 1988, and 1989. You should do that by November, 1987. Please act now!

REVISIONS TO COMPENSATORY LEAVE RULES Effective August 28, 1987, the USPS rule governing Attendance and Leave was revised. This revision includes authorization for supervisors to allow included employees (those completing white timecards) to accrue "overtime compensatory leave" in instances where an employee is required to work overtime. Prior to the rule change, included employees were only eligible to receive cash payment on the basis of one and one-half times the employee's hourly regular rate of pay for each hour of overtime worked. Overtime compensatory leave is credited on the basis of one and one-half hours of leave for each hour of overtime worked, up to a maximum of 120 hours of overtime compensatory leave. This provision does not apply to employees covered by the PBA contract or employees whose classification is covered by the Operational Services Unit.

The Personnel Department is in the process of revising the Administrative Affairs Policy and Procedure Manual Section 9.30 to reflect the applicable overtime and compensatory leave provisions. Department Heads should continue to follow the procedures outlined in Section 9.30 when requesting approval to assign overtime work and the subsequent reporting of overtime hours worked by employees.

### UNIVERSITY STATEMENT ON AIDS:

Acquired Immune Deficiency Syndrome (AIDS) is a deadly disease that by the end of 1985 afflicted approximately 15,000 Americans.

In the next few years the disease is expected to strike additional tens of thousands of people in the United States. We must anticipate that some members of this academic community will be affected. While AIDS can be contagious, medical research and experience have established that the responsible virus is transmitted by intimate sexual contact and by exposure to contaminated blood. There is no cause for excessive alarm, but there are compelling reasons to observe some basic precautions. These include, but are not limited to, reducing the number of sexual partners, knowing your sexual partners well, avoiding the exchange of body fluids through the proper use of condoms, and not using contaminated needles. Students and employees of the University who may become infected with the AIDS virus will not be excluded from enrollment or employment, or restricted in their access to University services or facilities, unless medically based judgments, in individual cases, establish that exclusion or restriction is necessary to the welfare of the individual or of other members of the University community. Persons who know or suspect they are infected are expected to seek expert medical advice and are obligated, ethically and legally, to conduct themselves responsibly in accordance with such knowledge, for the protection of others They are urged to share that information with one of the above listed persons so the University can respond to their health and emotional needs.
