IMPORTANT INSURANCE OPEN ENROLLMENTS INFORMATION.

Open Enrollment has been scheduled during the month of October for the following programs:

I. ALL GROUP HEALTH INSURANCE AND STATE LIFE INSURANCE PLANS Effective date of coverage: January 1, 1992.

Premiums for all health insurance plans will increase effective January 1, 1992 as follows:

Individual Coverage: Family Coverage:

From \$11.88/Bw. to \$12.83/Bw. From \$42.73/Bw. to \$46.15/Bw.

II. FLORIDA FLEXIBLE BENEFITS PLAN (i.e. Pretax Premiums, Medical Reimbursement and Day Care Reimbursement Accounts).

Effective date of coverage: December 1, 1991

An Annual Benefit Election Form will be mailed to your home address by the Division of State Employees' Insurance. This form MUST be completed and submitted to the Personnel Office no later than October 31, 1991 regardless of whether a change is being made or not.

III. MIDWEST LEGAL INSURANCE
Effective date of coverage: January 1, 1992

An enrollment packet will be mailed to your department by Midwest Legal Services. If you would like to enroll, please complete the application and return it to the Personnel Office within the open enrollment period. If you are already enrolled in this plan, no action is required at this time.

Effective with the paycheck of December 13, 1991, the premium for employees currently participating in the plan will be adjusted to reflect the new premium as follows:

SICK LEAVE POOL (OPEN ENROLLMENT THIS MONTH, OCTOBER, 1991)
Participation in the Pool is voluntary and is open to all full-time faculty, A&P, and USPS employees who have completed one year of employment with the State with a minimum of 64 hours of unused credited sick leave. To join, an employee will donate eight hours of his/her sick leave to the pool. An additional eight hours of sick leave will be requested only when the Pool is depleted below eighty hours. EMPLOYEES RAISE CONCERN OVER INCREASE IN PRESCRIPTION DRUG CO-PAYMENT Many FIU employees recently voiced concern to Blue Cross Blue Shield about the rising cost of prescription drugs under the State's Self-Insured Health Plan.

Contrary to common belief, the State's health insurance plan is not a Blue Cross Blue Shield (BCBS) policy. The plan is self-insured, with BCBS acting only as the claims processing agent. With a Self-Insured Plan, premiums collected are used directly to pay benefit claims. As claims' costs increase, action must be taken so that what is paid out in claims does not exceed what is paid in in premiums. Generally, a plan may raise premiums and/or modify benefits to accomplish this.

When the State's Prescription Drug Card Program was established in 1986, claims were \$11 million. Last year, drug claims exceeded \$41 million. Since this represents approximately 10% of the Plan's total claims costs, the 1991 Legislature decided changes in these benefits were required; hence, higher co-payments (\$11 for brand name drugs, \$5 for generic drugs). In the meantime you may find relief in the mail order program of the Self-Insured Plan. An employee can receive triple the quantity (a 90-day supply) through mail order for the same price as a 30-day supply filled at a pharmacy.
