

AN OPEN LETTER TO ALL FACULTY, STAFF AND STUDENTS

During the past several weeks there have been numerous rumors going around the community and the University regarding the future plans of one Charles E. Perry. These rumors have covered the waterfront--from politics to private enterprise to another presidency.

Now, let me set the record straight. When I accepted the presidency in July of 1969, I committed myself (to the Board of Regents and the Chancellor) to staying at least through our first graduating class—then scheduled for June of 1974. That commitment still stands. This is a minimum time commitment and it does not mean that I will automatically leave in June of 1974; nor does it mean that I plan to stay for any prescribed period of time after that. It does mean that after five years as president I feel that it would be time for me to re-evaluate my plans as they relate to this institution.

A recent newspaper article, not initiated by me, has implied that I am bored with my role as president. Nothing could be further from the truth. I have the most challenging position in American higher education, and believe me, I have plenty to keep me busy and involved! The same story also indicated that some dissatisfaction with the "Perry management style" contributed to the loss of five deans. This was misleading because only one of the six academic deans has left during the past three and one-half years—to return to teaching at this institution.


It is important for you to know that I am still as personally and professionally committed to this University as ever. Fortunately, my relationship with the Board of Regents is very good and I plan to keep it that way. However, the presidents in the State University System work at the pleasure of the Board, and the Board has the final responsibility to evaluate the effectiveness of the nine presidents.

This is the current and factual situation. I hesitated to write this letter, but decided to do so to answer your questions. My telephone has been ringing continually and the mail on this subject is beginning to be staggering. Rather than answering each one individually, I decided to prepare this response.

We are building a great University--made up of great people. We must not permit rumors to take our attention and our energy off the institution's basic mission--the education of students, service to the community and the promotion of greater international understanding.

BIDS OPENED FOR FOURTH MAJOR BUILDING SITE

Bids on the Multi-Function II Building and Central Utility Plant, which will be the University's fourth major building project, will be opened on Thursday, March 22, for the site work and pilings.

The bid opening, which will be held at 2 p.m. in Primera Casa 521, will be conducted by Donald Z. Bailey, Projects Manager for the State Department of General Services.

This project, according to Vice President Donald McDowell, is being broken down into construction components to insure completion by September, 1974. Bids on construction of the building, which has been budgeted at \$4,239,000, are expected to be let in April.

The three-story Multi-Function II Building will be located directly north of Deuxieme Maison, and will contain technology and science laboratories, the Media Center, instructional space for Fine Arts, and an experimental theater. The Central Utility Plant will be located behind this structure and will house all air conditioning and mechanical equipment for the campus. Architects are Dalton, Dalton and Little of North Miami and Cleveland.

CEREMONY MARKS OPENING OF INTERCOLLEGIATE ATHLETICS

Florida International will recognize the beginning of intercollegiate athletics at the University with a brief ceremony prior to a baseball doubleheader with Cornell University on Sunday, March 18, at 12:30 p.m.

The short program will include the introduction of the University's coaching staff by Dr. Paul Hartman, Chairman, Division of Health, Physical Education, Recreation and Athletics, and introduction of guests by President Perry. Faculty, staff and students are invited to attend the ceremony and game at Miami Dade Junior College-South campus field. Members of the University's Board of Advisors and Foundation as well as Cornell alumni in the area have also been invited.
