FREEDOM BEACH FESTIVAL – CANCELED EVENT

REPORTED BY MICHELLE SWABY-SMITH – VKBPT SPECIAL EVENTS LIAISON

- 1. EVENT WAS BOOKED ON APRIL 1, 2016 AND WAS SCHEDULED TO HAPPEN ON MAY 29, 2016
- 2. JOE (EVENT ORGANIZER) CAME TO THE OFFICE ON APRIL 1, 2016 AND WE DISCUSSED THE PROCEDURES OF DOING AN EVENT AT HVKBP. ADVISED HIM OF THE IMPORTANCE OF FIRST CONTACTING THE STATE DUE TO TURTLE NESTING SEASON. HE WOULD HAVE TO SPEAK WITH THEM ABOUT DOING AN EVENT THAT WOULD GO AFTER SUNSET. GAVE HIM THE CONTACT INFO FOR VANESSA DORNISCH AT FL DEPT OF ENVIRONMENTAL PROTECTION.
- 3. VANESSA RESPONDED TO THE REQUEST AND STATED THAT SHE WOULD NEED A SITE PLAN TO DETERMINE IF THEY WOULD ALLOW THE EVENT TO GO ON UNTIL 9PM
- 4. JOE TRAVELED OUT OF THE COUNTRY FOR 8 DAYS, SO THERE WAS NO COMMUNICATION UNTIL HE RETURNED. RECEIVED AN EMAIL FROM HIM ON APRIL 29TH, 2016 SAYING THAT HE APOLOGIZED BUT THAT HE HAD JUST RETURNED FROM CHINA.
- 5. ONCE VANESSA TOLD THE EVENT ORGANIZER THAT THEY COULD PROCEED WITH PLANNING AS LONG AS THE INTENT WAS TO NOT TO GO PAST 9PM AND ALL REGULATIONS WERE COMPLIED WITH. SHE ALSO FORWARDED THE EVENT FILE TO THE FWC. I INSTRUCTED JOE TO COMPLETE THE ONLINE APPLICATION FOR THE CITY OF MIAMI AT THAT POINT.
- 6. AYLIN NEVER RECEIVED THE ONLINE APPLICATION AND IT WAS ABOUT TWO WEEKS PRIOR TO THE EVENT DATE THEREFORE I INFORMED THE EVENT ORGANIZER THAT THEY WOULD NEED TO RESCHEDULE. THEY SELECTED JULY 3RD, 2016 FOR THE NEW DATE ON MAY 16, 2016
- 7. ON MAY 16TH, 2016, THE EVENT ORGANIZER (JOE) WAS INSTRUCTED TO COMPLETE THE ONLINE APPLICATION FOR THE CITY AS SOON AS POSSIBLE SO THAT AYLIN COULD ADD THE EVENT TO THE JUNE SPECIAL EVENTS MEETING. ALSO REQUESTED A NEW SITE PLAN SHOWING THE ADDTL VENDOR TENTS AND OTHER ACTIVATIONS. (THE ONE I HAD ONLY SHOWED THE STAGES, THE VIP TENT AND THE VIP SKYBOX. WE SCHEDULED A MEETING FOR 5/24/16.
- 8. JOE, FRANKEL & GARRETT CAME TO THE OFFICE ON 5/24/16. THEY CLAIMED TO HAVE SUBMITTED THE ONLINE APPLICATION. WHEN I CALLED AYLIN ON SPEAKER (DURING THE MEETING), SHE SAID THAT SHE NEVER RECEIVED THE ONLINE APPLICATION.
- 9. DURING THE MEETING GARRETT WAS REPEATEDLY OFFENSIVE AND MADE SEVERAL DEROGATORY COMMENTS TO ME (SPECIAL EVENTS LIAISON – HVKBP). ONE COMMENT WAS TO ASK "WHY THEY HAD TO DO THE EVENT IN THAT PIECE OF CRAP AREA....." HE MADE DISRESPECTFUL COMMENTS ABOUT THE TURTLES AND THE TROUBLE THE NESTING WAS CAUSING. HE ALSO TRIED TO CHALLENGE ME BY MAKING NEGATIVE COMMENTS ABOUT WHY "THE TRUST DOESN'T JUST LET THEM DO THE EVENT AT THE PARK FOR FREE...ISN'T IT TAX PAYERS DOLLARS FUNDING THE PARK". I EXPLAINED THAT THE TRUST NEEDS TO GENERATE ITS OWN FUNDS TO OPERATE THE PARK BUT HE KEPT DEMANDING THAT WE GIVE THE EVENT EVERYTHING FOR FREE. VERY DISRESPECTFUL!

10. THE CONCERN WITH THIS FREEDOM BEACH FESTIVAL EVENT GROUP AND THE IMPETUS FOR CANCELING THE EVENT AT HVKBP, IS THAT THEY HAVE DEMONSTRATED THAT THEY WILL NOT COMPLY WITH THE REQUIREMENTS IN A TIMELY MANNER AND THEIR ACTIONS GIVE US CAUSE FOR CONCERN AS IT RELATES TO THEM RESPECTING THE TURTLE NESTING RULES. THEY ARE CONFRONTATIONAL ON MANY LEVELS.

We have denying this proposed event happening at Historic Virginia Key Beach Park due to several circumstances and request the following information for our records:

What date did you receive the site plan from the event organizers? I received the site plan on May 6, at which time I additionally requested a schedule and lighting plan (see attached email chain).

What date did you refer them to FWC? On May 12, Garret Nathan sent me the schedule (see attached email) and contacted me via telephone requesting guidance with the lighting plan. I referred him to FWC for assistance, but the FWC contact was out of the office for the week. On May 13, I sent him the lighting plan from a previous HVKBP event for guidance (see attached email chain). On May 17, the FWC contact responded to Mr. Nathan (see attached email). Did you send them a list of requirement in order to proceed with this event ending at 9pm? The only requirement for an event with no components on the beach is turtle-friendly lighting after 9 PM. It was my understanding they were in the process of creating the lighting plan.

Who was your main point of contact for the event? And were they willing to comply to the requirements without resistance? My main point of contact was Garret Nathan. Yes, he seemed willing to comply with my requests.



Nathan,

What is your event and when? The biggest recommendations I can give to you for the lighting design is to utilize long wavelength lights (amber, red, red-orange) and keep lights to minimum necessary for the event. Lights should be downward directed and facing away from the beach. When submitting something to FWC for review, we need to see all proposed lighting – stage, security, vendor, etc.
