During formative period of Corporation, J.F.Jaudon "carried on" the expenses, office, field, promotion, engineering, constructive, efforts to make sale, timber certificate, and incidental expenses advanced to Geo.F.Cook and spent by himself, on all things to further the interest of the property, and rendered statement of \$60,000.00 of such expenditures for which stock was issued to him

D.A.McDougal also accepted stock for advances made for taxes etc, Geo F.Cook rendered a bill now carried as an liability.
