and others-----I do not know of any acreage changing hands
in the past five years at less than fifty dollars per acre.

Lands in either of these two townships rents for ten dollars
per acre per crop season. As roads are constructed it will not
be difficult to rent several thousand acres annually at ten dol-
lars per acre per season.

Taxes have been paid up to date on some of these lands, however
it is anticipated that all taxes will be paid soon.

Hardly think many people are qualified to make a fair apprais-
ment of lands as a whole---surely they have a value of \$500,000.00.
especially if put to use and production.

Florida and Collier County will vote on the repeal of Article
