AN ORDINANCE CLOSING CERTAIN PORTIONS OF PEAR AVENUE,
MANGO AVENUE, JEFFERSON AVENUE, FOURTEENTH STREET, THIRTEENTH STREET AND TWELFTH STREET; PORTIONS OF THE PUBLIC
ALLEYS NOW EXTENDING IN A NORTHERLY AND SOUTHERLY DIRECTION THROUGH BLOCKS SIXTY-SIX (66), SIXTY-SEVEN (67), SIXTY-EIGHT (68), NINETY (90), NINETY-ONE (91), NINETY-TWO
(92), NINETY-THREE (93), NINETY-FOUR (94), NINETY-FIVE
(95), ONE HUNDRED SEVEN (107), ONE HUNDRED EIGHT (108),
ONE HUNDRED NINE (109), THE PUBLIC ALLEY RUNNING BETWEEN
LOTS "E" AND "F", AND THE PUBLIC ALLEY RUNNING BETWEEN
LOTS "G" AND "H", ALL IN THE CITY OF MIAMI BEACH, FLORIDA,
AS THE SAME ARE SHOWN, MARKED AND DESIGNATED ON A PLAT OF
OCEAN BEACH, FLORIDA, ADDITION NO. 3, DULY FILED IN PLAT
BOOK NO. 2, ON PAGE 81 OF THE PUBLIC RECORDS OF DADE COUNTY, FLORIDA, FOR A TERM OF TWELVE YEARS.

WHEREAS, this body has been petitioned by the owners of Blocks sixty-six (66), sixty-seven (67), sixty-eight (68), and ninety (90), ninety-one (91), ninety-two (92), ninety-three (93), ninety-four (94), ninety-five (95), oge hundred seven (107), one hundred eight (108), one hundred nine (109), and Lots "E", "F", "G" and "H", as the same are shown, marked and designated on a plat of Ocean Beach, Florida, Addition No. 3, duly filed in Plat Book No. 2, at page 81, of the public records of Dade County, Florida, and all the land adjoining said blocks ninety-three (93), one hundred nine (109) and the West 270 feet of Block twenty (20), (as shown by said Plat), on the north, and all the land adjoining said Lots "E", "F", "G" and "H" on the South, to close that portion of Pear Avenue (now Lenox Avenue) extending from the South line of Lots "E", "F", "G" and "H" to the North line of said Blocks ninety-three (93) and one hundred nine (109); and that part of Mango Avenue (now Michigan Avenue), extending from the North line of Eleventh Street to the North line of said Blocks twenty (20) and ninety-three (93) and that part of Palm Avenue (now Jefferson Avenue) extending from the North

thex North line of Eleventh Street, to the North line of Fourteenth Street; and that part of Fourteenth Street extending from the East line of Alton Road to the West line of Pine Avenue, (now Meridian Avenue); and that part of Thirteenth Street, extending from the East line of Alton Road to the West Line of said Meridian Avenue; and that part of Twelfth Street extending from the East line of Alton Road to the West line of said Meridian Avenue; and the public alleys now extending in a Northerly and Southerly direction through said Blocks sixtysix (66), sixty-seven (67), sixty-eight (68), ninety (90), ninety-one (91), ninety-two (92), ninety-three (93), ninetyfour (94), ninety-five (95), one hundred seven (107), one hundred eight (108), one hundred nine (109), and the public alley running between said Lots "E", and "F", and the public alley running between said Lots "G" and "H"; and it appearing that all owners of lots which might be injured or affected by such proposed vacation are in favor of same; NOW,

THEREFORE, BE IT ORDAINED, by the City of Miami Beach, Florida, that that portion of Pear Avenue (now Lenox Avenue) extending from the South line of said Lots "E", "F", "G" and "H" to the North line of said Blocks ninety-three (93) and one hundred nine (109); and that part of Mango Avenue (now Michigan Avenue), extending from the North line of Eleventh Street to the North line of said Blocks twenty (20) and ninety-three (93); and that part of Palm Agenue (now Jefferson Avenue) extending from the North line of Eleventh Street to the North line of Fourteenth Street; and that part of Fourteenth Street extending from the East line of Alton Road to the West line of Pine Avenue, (now Meridian Avenue); and that part of Thirteenth Street, extending from the East line of Alton Road to the West line of said Meridian Avenue; and that part of Twelfth Street extending from the East line of Alton Road to the West line of said Meridian Avenue; and the public alleys now extending in a Northerly and Southerly direction through said Blocks sixty-six (66), sixty-seven (67), sixty-eight (68), ninety (90), ninety-one (91), ninety-two (92), ninety-three (93),

ninety-four (94), ninety-five (95), one hundred seven (107), one hundred eight (108), one hundred nine (109), and the public alley running between said Lots "E" and "F"; and the public alley running between said Lots "G" and "H" be and the same are hereby closed, for a period of twelve years from the passage of this ordinance.

Be it further ordained that this ordinance in no wise grants or conveys the fee in said streets or alleys to the abutting owners thereon, or their heirs, successors or assigns, and is not intended to act as an abandonment or vacation of said streets and alleys on the part of the City of Miami Beach.

This ordinance shall take effect after the same shall have been posted as required by law for a period of thirty days.
