AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MIAMI BEACH, FLORIDA, REQUIRING THE NUMBERING OF ALL HOUSES WITHIN THE CITY LIMITS OF SAID CITY AND PRESCRIBING A PENALTY FOR THE VIOLATION OF THE SAME.

BE IT ORDAINED by the City Council of the City of Miami Beach, Florida,

Section 1, that from and after the passage of this Ordinance, its approval and publication as required by law, it shall be the duty of the City Engineer to furnish to any and all applicants the correct numbers for houses as defined and prescribed by Ordinance No. 102, passed at the recess meeting held at the City Council chambers September 5, 1917.

Section 2, that from and after the passage, approval and publication of this ordinance as required by law, it shall be the duty of all owners or occupants of houses or buildings within the city limits of the City of Miami Beach, Florida, to obtain from the City Engineer the correct numbers of their respective buildings, for which there shall be no fee charged, and to cause such number to be placed on their houses or buildings within ten days after the completion of such building or buildings, such numbers not to be less than one and one-half inches in height. This ordinance shall not be construed to mean that the City Engineer or the City of Miami Beach shall furnish to such owner or occupant the material out of which said number or numbers shall be made.

Section 3. Any owner or occupant of any building who may fail to comply with the provisions of this ordinance shall upon conviction be punished by fine not exceeding \$25.00 or by imprisonment not exceeding 30 days.
