

AN ORDINANCE VACATING CERTAIN ALLEYS IN THE CITY OF MIAMI BEACH, DADE COUNTY, FIORIDA, AS THE SAME ARE DESIGNATED UPON A MAP OF OCEAN BEACH, FLORIDA, ADDITION NO. 3, BEING A SUBDIVISION OF PART OF THE No. 3, TWP. 54 SOUTH, R. 42 EAST (ALSO OTHER LANDS), RECORDED IN PLAT BOOK 2, AT PAGE 81, OF THE PUBLIC RECORDS OF DADE COUNTY, FLORIDA.

BE IT ORDAINED by the City Council of the City of Miami Beach, Florida, that:

Section 1. That the following described alleys lying and being within the corporate limits of said City, according to a Map of Ocean Beach, Florida, Addition No. 3, being a subdivision of part of the North Half of Fractional Section 3, Township 54 South, Range 42 East (also other lands), recorded in Plat Book 2, at page 81, of the Public Records of Dade County, Florida, be, and the same are hereby, vacated, discontinued and abolished:

- (a) That certain alley running in a Northerly and Southerly direction between Lots A and B, according to said above designated map or plat, from Eighth Street to an unplatted tract of land lying North of, and contiguous to, said Lots A and B; and
- (b) That certain alley running in a Northerly and Southerly direction between Lots C and D, according to said above designated map or plat, from Eighth Street to an unplatted tract of land lying North of, and contiguous to, said Lots C and D.

Section 2. This ordinance shall take effect immediately upon its passage and after posting at the City Hall of said City of Miami Beach for a period of four weeks.

Section 3. All ordinances or parts of ordinances in conflict

herewith are hereby repealed.
