

ORDINANCE NO. 155

AN ORDINANCE VACATING THAT PORTION OF A PUBLIC ALLEY WHICH EXTENDS IN A NORTHERLY AND SOUTHERLY DIRECTION THRU BLOCK THIRTY SEVEN ACCORDING TO THE AMENDED MAP OF THE OCEAN FRONT PROPERTY OF THE MIAMI BEACH IMPROVEMENT COMPANY.

Whereas, this body has been petitioned by the owners of certain lots abutting upon that portion of a public alley which extends in a northerly and southerly direction thru Block numbered thirty-seven (37), according to an amended map of the Ocean Front Property of the Miami Beach Improvement Company, in the City of Miami Beach, Dade County, Florida, to vacate that portion of such alley. And it appearing that all owners of lots which might be injuriously affected by such proposed vacation are in favor of the same; now

THEREFORE BE IT ORDAINED by the City of Miami Beach, Florida, that that portion of the public alley which extends thru Block numbered thirty-seven (37), according to the amended map of the Ocean Front property of the Miami Beach Improvement Company, said map being recorded in Plat Book No. 5, pages 7 and 8 of the Public Records of Dade County, Florida, and lying between the north line of Eighteenth Street, now Forty-second Street, and the south line of Nineteenth Street, now Forty-third Street, and which lies between lots numbered one, two, three and four on the east thereof, and lots five, six, seven and eight on the west thereof, be and the same is hereby vacated, discontinued and abolished.

This Ordinance shall take effect after the same shall have been posted at the door of the City Hall of the said City of Miami Beach, Florida. There being no public market place in said City. Said posting to be for a period of 30 days.
