BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MIAMI BEACH, FLORIDA:

SECTION 1: That it shall be unlawful for any person or persons driving a vehicle of any description, however drawn, or propelled to pass a street car or street rail-way car while such street car or railway car is at a standstill for the purpose of receiving or discharging passengers.

SECTION 2: It shall be unlawful for any person, firm or corporation, whether agent or employer, to leave doors of street cars open except while passengers are being actually received or discharged.

SECTION 3: Any person violating this ordinance shall, upon conviction, be fined not exceeding Fifty (\$50) Dole lars or by imprisonment in the City Jail not exceeding twenty (20) days, or by both such fine and imprisonment.
