AN ORDINANCE OF THE CITY OF MIAMI BEACH, FLORIDA, AMENDING SECTION XI OF ORDINANCE #163 OF SAID CITY ENTITLED, "AN ORDINANCE OF THE CITY OF MIAMI BEACH, FLORIDA, PRESCRIBING RULES AND REGULATIONS AS TO PLUMBING WORK; THE INSTALLATION OF PLUMBING, THE BUILDING OR INSTALLING OF SEPTIC TANKS; HROVIDING FOR THE GRANTING OF A PERMIT, PERMITTING PLUMBING; PROVIDING FOR AN EXAMINING BOARD TO EXAMINE PERSONS AS TO THEIR QUALIFICATIONS AS PLUMBERS; FIXING THE QUALIFICATIONS OF PERSONS WHO MAY ENGAGE IN THE PLUMBING BUSINESS OR TRADE IN SAID CITY; PROVIDING FOR A PLUMBING INSPECTOR FOR SAID CITY; MAKING PROVISIONS WITH REFERENCE TO MERCHANT PLUMBERS AND PROVIDING FOR A PENALTY FOR THE VIOLATION OF THIS ORDINANCE," WHICH WAS ADOPTED AUGUST 17th, A. D.? 1921......

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MIAMI BEACH, FLORIDA:

That Section XI of an ordinance entitled, "An ordinance of the city of Miami Beach, Florida, prescribing rules and regulations as to plumbing work; the installation of plumbing, the building or installing of septic tanks; providing for the granting of a permit, permitting plumbing; providing for fees for such permits; providing for an examining board to examine persons as to their qualifications as plumbers; fixing thequalifications of persons who may engage in the plumbing business or trade in said City; providing for a plumbing Inspector for said City; making provisions with reference to merchant plumbers and providing for a penalty for the violation of this ordinance", which was adopted August 17th, A. D., 1921, be amended to read as follows:

SECTION XI. Examining Board.

The Examing Board of Plumbers of the City of Miami Beach, shall consist of the Plumbing Inspector of said City, and the Sanitary and Building Committeemen of the City Council of said City.

Each member of said Examining Board, attending an examination, shall receive a fee of fifty cents for each applicant examined. Such fee shall be paid out of the funds of the City of Miami Beach. The said City shall provide the examining Board with the necessary forms, books, blanks, tools and materials to properly conduct the examination.

AN ORDINANCE OF THE CITY OF MIAMI BEACH, FLORIDA, AMENDING SECTIONS, XI, XLVI AND SECTION L OF ORDINANCE NUMBER 163 ENTITLED, "AN ORDINANCE OF THE CITY OF MIAMI BEACH FLORIDA PRESCRIBING RULES AND REGULATIONS AS TO PLUMBING WORK; THE INSTALLATION OF PLUMBING, THE BUILDING OR INSTALLING OF SEPTIC TANKS; PROVIDING FOR THE GRANTING OF A PERMIT, PERMITTING PLUMBING; PROVIDING FOR FEES FOR SUCH PERMITS; PROVIDING FOR AN EXAMINING BOARD TO EXAMINE PERSONS AS TO THEIR QUALIFICATIONS AS PLUMBERS; FIXING THE QUALIFICATIONS OFPERSONS WHO MAY ENGAGE IN THE PLUMBING BUSINESS OR TRADE IN SAID CITY; PROVIDING FOR A PLUMBING INSPECTOR FOR SAID CITY; MAKING PROVISIONS WITH REFERENCE TO MERCHANT PLUMBERS AND PROVIDING FOR A PENALTY FOR THE VIOLATION OF THIS ORDINANCE."

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MIAMI BEACH, FLORIDA:

SECTION 1: That section XI, section XLVI and section L of ordinance number 163 of the City of Miami Beach Florida, entitled:

"An ordinance of the City of Miami, Beach Florida, prescribing rules and regulations as to plumbing work; The installation of plumbing, the building or installing of septic tanks; providing for the granting of a permit, permitting plumbing; providing for an examining board to examine persons as to their qualifications as plumbers; fixing the qualifications of persons who may engage in the plumbing business or trade in said city; providing for a plumbing inspector for said city; making provisions with reference to merchant plumbers and providing for a penalty for the violation of this ordinance."

SECTION XI: Examining Board. The Examining Board of plumbers of the City of Miami Beach shall consist of the Sanitary Committeemen the building committeemen of said City and the Plumbing Inspector of said City. Which Examining Board of plumbers shall serve during the pleasure of the City Council of said City. Each member of the Examining Board attending any examination of plumbers shall receive a fee of fifty cents for each applicant examined, such fee to be paid out of the funds of the City of Miami Beach. And said City shall provide the Examining Board with the necessary forms, books, blanks, tools and materials to properly conduct the examination.

SECTION XLVI. Penalties. Every person, as principal, agent, manager or employee, violating, failing, neglecting or refusing to

deemed guilty of a misdemeanor and, upon conviction thereof, shall be punished by a fine not exceeding \$200.00 or by imprisonment in the City Jail for not more than ninety days, or by both such fine and imprisonment; and every day during any portion of which any of the provisions of this ordinance shall be violated shall constitute a misdemeanor and shall be punished as herein provided.

SECTION L. Any person, the mamber of any firm or any officers of any corporation who shall violate any of the provisions of this ordinance shall, upon conviction, be fined not more than \$200.00 or be imprisoned in the City Jail not more than ninety days, or both such fine and imprisonment.

Any person, the mamber of any firm or any introduction who shall violate any of the provisions of this ordinance shall, upon conviction, be fined not more than \$200.00 or be imprisoned in the City Jail not more than ninety days, or be the con fine and imprisonment.
