

ORDINANCE #179.

AN ORDINANCE OF THE CITY OF MIAMI BEACH, FLORIDA, AUTHORIZING THE ISSUANCE OF BONDS OF SAID CITY IN THE FOLLOWING SUMS FOR THE FOLLOWING PURPOSES: (1) SEVENTY THOUSAND DOLLARS FOR THE PURPOSE OF CONSTRUCTING A BUILDING, THE LAYING OF DRAINS AND THE PURCHASE OF LAND, MACHINERY AND EQUIPMENT, ALL FOR THE OPERATION OF A PLANT FOR NEUTRALIZING, DESTROYING AND DISPOSING OF SEWERAGE, (2) FIFTY-FIVE THOUSAND DOLLARS FOR THE CONSTRUCTION OF SANITARY SEWERS, CALLING A SPECIAL ELECTION TO DETERMINE WHETHER SUCH BONDS SHALL BE ISSUED, REGULATING AND PROVIDING FOR SAID ELECTION AND PROVIDING A FORM OF BALLOT TO BE USED IN SAID ELECTION.....

WHEREAS The City Council of the City of Miami Beach, Florida, deems it advisable to issue bonds of said City in the sum and for the purposes following: (1) Seventy Thousand Dollars for the purpose of constructing a building, the laying of drains and the purchase of land, machinery and equipment, all for the operation of a plant for neutralizing, destroying and disposing of sewerage, and (2) Fifty-five Thousand Dollars for the construction of sanitary sewers,

NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MIAMI BEACH, FLORIDA:

Section 1. That the City of Miami Beach, Florida, issue negotiable coupon bonds of said City in the sums and for the purposes following: (1) Seventy Thousand Dollars for the purpose of the construction of a building, the laying of drains and the purchase of land, machinery and equipment, all for the operation of a plant for neutralizing, destroying and disposing of sewerage, and (2) Fifty-five thousand Dollars for the construction of sanitary sewers, the aggregate of which said sums are not in excess of ten per cent. of the assessed valuation of all real and personal property situated within the corporate limits of said City, PROVIDED, HOWEVER, that said bonds shall not be issued until after the same shall have been submitted to vote of the duly registered and qualified voters of said City and until after said issuance shall have been authorized by the vote of a majority of the qualified electors participating in an election herein called for that purpose.

Section 2. That the questions of issuing said bonds for said two purposes be submitted to said voters separately.

Section 3. That said City Council does hereby call a special election to be held in the City Hall in said City on the 25th day of July, A. D., 1922, at which special election the questions whether the following sums of bonds shall be issued for the following purposes: (1) Seventy Thousand Dollars for the purpose of the construction of a building, the laying of drains and the purchase of land, machinery and equipment, all for the operation of a plant for neutralizing, destroying and disposing of sewerage, and (2) Fifty-five Thousand Dollars for the construction of sanitary sewers shall be submitted to the duly registered and qualified voters of said City.

Section 4. That the registration books of said City shall be open from ten o'clock a. m. until five o'clock p. m. each day, Sundays excepted, from June 21, to July 15, A. D., 1922, for the registration of all persons eligible for registration and who are not now registered.

Section 5. That Jeremiah Reid, John L. Crist and J. Arthur Pan-coast be and they are hereby appointed inspectors and Val Cleary is hereby appointed Clerk to hold and conduct said election at said voting place on said day, which names the City Clerk shall certify to the Mayor.

Section 6. That at the said election the polls shall be open from eight o'clock a. m. until sun down on the day thereof.

Section 7. That said inspectors and clerk certify the result of said election to said City Council within five days after said election.

Section 8. That the form of ballot to be used at said election shall be substantially as follows:

Section 9. That a notice of said election be given by the Mayor of said City by publication in the Miami Metropolis, a newspaper published in Miami, Florida, once a week for a period of thirty days, there being no newspaper published in said City of Miami Beach, and by posting the same notice for a period of thirty days in three conspicuous places in the City of Miami Beach, one of which shall be at the City Hall, one at the post office and one at Hardie's Casino.

Section 10. That said notice of said election be in substantially the following form:

NOTICE is hereby given that an election has been called by the City Council of the City of Miami Beach, Florida, and will be held at the City Hall on the 25th day of July, A. D., 1922, at which there will be submitted to the duly registered and qualified voters of said City, the questions whether negotiable coupon bonds of said City in the following sums be issued for the following purposes: (1) Seventy Thousand Dollars for the construction of a building, the laying of drains and the purchase of land, machinery and equipment, all for the operation of a plant for neutralizing, destroying and disposing of sewerage, and (2) Fifty-five Thousand Dollars for the construction of sanitary sewers. Inspectors and clerk have been appointed to conduct said election at said time and place. The registration books of said City will be open from ten o'clock a. m. until five o'clock p. m. each day, Sunday excepted, from June 21 to July 15, 1922, for the purpose of registration of persons not now registered.

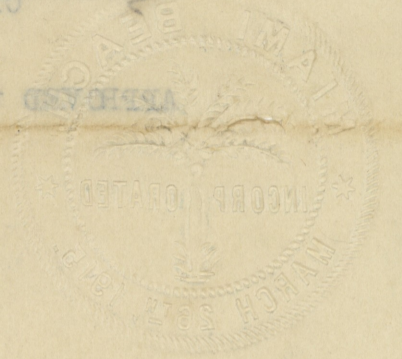
