## ORDINANCE NO. 206

AN ORDINANCE OF THE CITY COUNCIL
OF THE CITY OF MIAMI BEACH, FLORIDA,
CALLING AN ELECTION FOR THE PURPOSE
OF SUBMITTING TO THE QUALIFIED VOTERS
OF SAID CITY FOR THEIR APPROVAL ORDINANCE NO. 204 AND ORDINANCE NO. 205,
OF SAID CITY, AND MAKING PROVISIONS
RELATIVE TO THE HOLDING OF SAID ELECTION.

WHEREAS, the City Council of the City of Miami Beach, Florida, has this day adopted its Ordinance No. 204 and Ordinance No. 205, the titles of which are hereinafter set forth, by giving each of them its third reading in full and by the unanimous, affirmative vote of said City Council taken upon a call of the roll, which Ordinances, before they become effective as a law, must have been approved by a majority of the qualified voters of the City of Miami Beach, Florida, voting at an election held for that purpose:

NOW, BE IT ORDAINED by the City Council of the City of Miami Beach, Florida:

Section 1. That a special election is hereby called and directed to be held at the City Hall in the City of Mismi Beach, Florida, from eight o'clock A. M., until sundown, on the 20th day of May, A.D. 1924, for the purpose of submitting to a vote of the qualified voters of the City of Mismi Beach, Florida, voting at said election, the question whether Ordinance No. 204, adopted by the City Council of the City of Mismi Beach, Florida, April 9th, 1924, and entitled: "AN ORDINANCE GRANTING TO S. R. INCH, HIS HEIRS, LEGAL REPRESENTATIVES AND ASSIGNS, THE RIGHT, PRIVILEGE, OR FRANCHISE FOR THE PERIOD OF THERTY YEARS, TO CONSTRUCT, MAINTAIN AND OPERATE IN, UNDER, UPON AND ACROSS THE PRESENT AND FUTURE STREETS, AVENUES, ALLEYS, HIGHWAYS, BRIDGES, EASEMENTS AND OTHER PUBLIC PLACES IN THE CITY OF MIAMI BEACH, FLORIDA, AND ITS SUGGESSORS, ELECTRIC LIGHT AND POWER LINES, TOGETHER WITH ALL THE NECESSARY OR DESIRABLE APPURTENANCES, FOR THE PURPOSE OF SUPPLYING ELECTRICITY TO SAID CITY, AND ITS SUGCESSORS, THE INHABITANTS THEREOF, AND TO PERSONS AND CORPORATIONS BEYOND THE LIMITS THEREOF, FOR LIGHT, HEAT, POWER AND OTHER PURPOSES, AND IMPOSING PROVISIONS AND CONDITIONS RELATING THEREFO:—" and the question whether Ordinance No. 205, adopted by the City Council of the city of Mismi Beach, Florida, April 9, 1924, and entitled: "AN ORDINANCE GRANTING TO THE MIAMI BEACH RAILWAY COMPANY, ITS SUGGESSORS AND ASSIGNS, THE RIGHT, PRIVILEGE OR FRANCHISE FOR THE PERIOD OF THIRRY YEARS, TO CONSTRUCT, EQUIP, OPERATE AND MAINTAIN, ON, OVER, ALONG AND ACROSS CERTAIN SPECIFIED STREETS, AVENUES, ALLEYS, HIGHWAYS, BRIDGES AND PUBLIC FLACES IN THE CITY OF MIAMI BEACH, FLORIDA, AND ITS SUGGESSORS, A SPREET RAILWAY, OR OTHER TRANSPORTATION SYSTEM, AND IMPOSING PROVISIONS AND CONDITIONS RELATING THEREFO:—"be approved and become a law.

Section 2. That the City Clerk, who is also Supervisor of Registration, open the registration books of said City for such election from ten o'clock A. M., until five o'clock P. M., each day Sunday excepted, from this day until and including May 10th, 1924, for the purpose of registering those persons who are qualified to register for such election.

Section 3. That Milton H. Farr and William Tomlinson and Mrs. Ethel Stephenson, be and they are hereby appointed Inspectors, and James R. Kelly is hereby appointed Clerk for the purpose of holding and conducting said election at the time and place aforesaid, which names the said Clerk shall certify to the Mayor. Section 4. That said Inspectors and said Clerk shall certify the result of said election to said City Council within five days after the holding of such election. Section 5. That thirty days' notice of such election be given by the Mayor of said City, by posting the notice hereinafter provided for once each week for thirty days in three conspicuous places in said City of Miami Beach, Florida, to-wit: At the City Hall, the Post Office and at Hardie's Casino, and by publishing the same, once each week, for thirty days in The Daily Tribune, a newspaper published in the City of Miami Beach, Florida, and of general circulation in said City. City. Section 6. That said notice of election shall be in substantially the following form; "Notice is hereby given that an election has been called by the City Council of the City of Miami Beach, Florida, and will be held at the City Hall in said City on the 20th day of May, A. D., 1924, at which there will be submitted to the qualified voters of said City the following questions:-A) Shall Ordinance No. 204, adopted by the City Council of the City of Miami Beach, Florida, April 9, 1924, and entitled "AN ORDINANCE GRANTING TO S. R. INCH, HIS HEIRS, LEGAL REPRESENTATIVES AND ASSIGNS, THE RIGHT, PRIVILEGE, OR FRANCHISE FOR THE PERIOD OF THIRTY YEARS, TO CONSTRUCT, MAINTAIN AND OPERAGE IN UNDER UPON AND ACROSS THE PRE-MAINTAIN AND OPERATE IN, UNDER, UPON AND ACROSS THE PRE-SENT AND FUTURE STREETS, AVENUES, ALLEYS, HIGHWAYS, BRIDGES, EASEMENTS AND OTHER PUBLIC PLACES IN THE CITY OF MIAMI BEACH, FLORIDA, AND ITS SUCCESSORS, ELECTRIC LIGHT AND POWER LINES, TOGETHER WITH ALL THE NECESSARY OR DESIRABLE APPURTENANCES, FOR THE PURPOSE OF SUPPLYING ELECTRICITY TO SAID CITY, AND ITS SUCCESSORS, THE INHABITANTS THEREOF, AND TO PERSONS AND CORPORATIONS BEYOND THE LIMITS THEREOF, FOR LIGHT, HEAT, POWER AND OTHER PURPOSES, AND IMPOSING PROVISIONS AND CONDITIONS RELATING THERETO:—" be approved and become a law?

B) Shall Ordinance No. 205, adopted by the City Council of the City of Miami Beach, Florida, April 9, 1924, and entitled An Ordinance Granting to the Miami Beach Railway company, Its successors and assigns, the right, privilege or Franchise for the Period of Thirty Years, to construct, equip, Operate and Maintain, on, over, along and across certain specified streets, avenues, alleys, highways, bridges and public Places in the City of Miami Beach, Florida, and its successors, a street Railway, or other transportation system, and imposing Provisions and conditions relating thereto:—" be approved and become a law?

Inspectors and a Clerk have been appointed to conduct such election at said time and place.

The registration books will be open from ten o'clock A.M., until five o'clock P. M., Sunday excepted, from this day, until and including May 10, 1924, for the purpose of registering persons qualified to register for such election.
