

ORDINANCE NO. 227

AN ORDINANCE OF THE CITY COUNCIL
OF THE CITY OF MIAMI BEACH, FLORI-
DA, PRESCRIBING THE SALARIES TO BE
PAID TO OFFICERS HEREIN DESIGNATED.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MIAMI BEACH,
FLORIDA:

Section 1: That the salaries set opposite the names of
the following described officers of the City of Miami Beach are
hereby prescribed and authorized to be paid at the end of each
month, for which services are rendered by such officers:



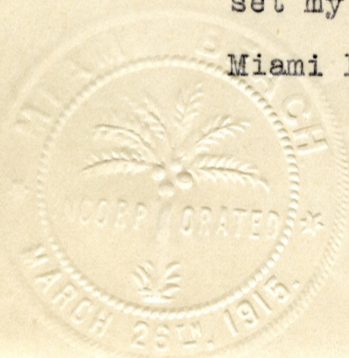
