

ORDINANCE NO. 276

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MIAMI BEACH, FLORIDA, PRESCRIBING THE TERRITORY WITHIN THE LIMITS OF SAID CITY WITHIN WHICH GASOLINE, BENZINE, NAPHTHA AND OTHER EXPLOSIVES SHALL NOT BE STORED OR KEPT FOR SALE, AND WITHIN WHICH BUILDINGS OR BUSINESSES FOR SAID PURPOSES SHALL NOT BE ERECTED OR OPERATED.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MIAMI BEACH, FLORIDA:

SECTION 1. That for the promotion of public health, safety, morals and general welfare of the hereinafter described territory it shall be unlawful to store or keep for sale in excess at any one time, of more than Fifty (50) gallons of gasoline, benzine, naptha or other explosives; or to build, rent, operate or conduct any building or business for any of said purposes within the hereinafter described territory, to-wit:

That part of the City of Miami Beach, Florida, bounded on the South by Dade Boulevard and Twenty-Fourth (24th) Street East of Pancoast Lake, and South of a line extended easterly and westerly from the Atlantic Ocean to Biscayne Bay through La Gorce Canal, except that land lying East of Indian Creek and North of Forty-Fourth (44th) Street.


SECTION 2. Any person, firm or corporation found guilty of violation of this ordinance shall be fined not exceeding Five Hundred (\$500.00) Dollars and/or be imprisoned in the City Jail not exceeding Ninety (90) days.

SECTION 3. All ordinances and parts of ordinances in conflict herewith are hereby repealed.

SECTION 4. WHEREAS, an emergency exists and it is necessary for the protection of the public health, safety, morals and welfare of said City, this ordinance should be given its three readings at this meeting, and it shall be in full force and effect upon its due passage and approval.

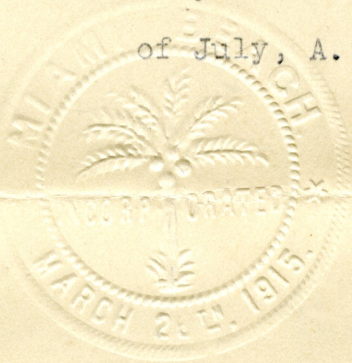
