

ORDINANCE NO. 277

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MIAMI BEACH, FLORIDA, AMENDING SECTION THIRTEEN (13) OF ORDINANCE NO. 247 OF SAID CITY, PROVIDING ADDITIONAL SPECIAL RULES AND REGULATIONS IN THE CONSTRUCTION, INSTALLATION AND REPAIR OF ELECTRICAL WORK.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MIAMI BEACH, FLORIDA:

SECTION 1. That Section Thirteen (13) of Ordinance No. 247 of the City of Miami Beach be and the same is hereby amended by adding thereto the following paragraphs:

"All boxes, cabinets and fittings shall be galvanized or the equal thereof.

No circuit shall have more than ten (10) outlets for lights, brackets or receptacles except by special permission of the Electrical Inspector.


Ground connections shall not be made to house piping, but shall consist of  $1\frac{1}{4}$  inch galvanized conduit, provided with drive point and cap, driven in the ground so that the point shall reach below the natural water level. The drive point shall be perforated so as to admit water inside the pipe. The ground wire, which shall be not less than No. 2, R. C. in  $3/4$ " conduit, shall be attached to ground rod with an approved clamp.

Iron plug shall be of Pilot Lamp type, connected to heat or refrigerator circuit.


In the installation of electrical wiring, no ceiling joist shall be notched without special permission of the Electrical Inspector."

SECTION 2. All ordinances or parts of ordinances in conflict herewith are hereby repealed.



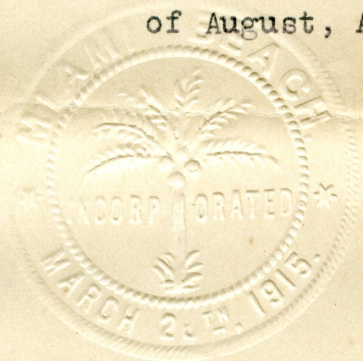
