AN ORDINANCE ESTABLISHING A SCHEDULE OF SALARIES TO BE PAID TO EMPLOYEES OF THE CITY OF MIAMI BEACH, FLORIDA, AND FIXING THE RATES THEREOF.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MIAMI BEACH, FLORIDA, That a schedule of rates of salaries for employees of the City of Miami Beach be and the same is hereby established as follows:




SECTION 3: Ordinance No. 292 and all other ordinances, or parts of ordinances, in conflict with this ordinance are hereby repealed.



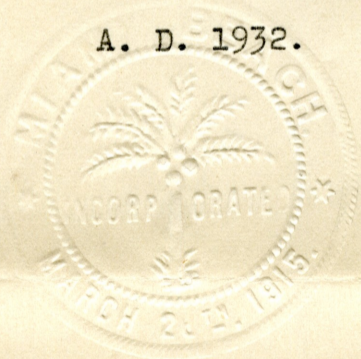


