## ORDINANCE NO. 303

AN ORDINANCE OF THE CITY OF MIAMI BEACH, FLORIDA, DESIGNATING AND NAMING CERTAIN STREETS, AVENUES, DRIVES AND HIGHWAYS IN SAID CITY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MIAMI BEACH, FLORIDA:

SECTION 1: That that certain highway shown and designated as Miami Avenue on Plat of Ocean Beach Subdivision, recorded in Plat Book 2, at Page 35, on Plat of Ocean Beach Addition Number 1, recorded in Plat Book 3, at Page 11, on Plat of Ocean Beach Addition Number 2, recorded in Plat Book 2, at Page 56, on Plat of Ocean Beach Addition Number 3, recorded in Plat Book 3, at Page 31, on Plat of Friedman & Cope's Subdivision, recorded in Plat Book 4, at Page 53, on Plat of Fisher's First Subdivision of Alton Beach, recorded in Plat Book 2, at Page 77, on Plat of Pine Ridge Subdivision, recorded in Plat Book 6, at Page 34, on Plat of Resubdivision of Blocks G, H, J, K, and Triangular Tract of The Ocean Front Property of the Miami Beach Improvement Company, recorded in Plat Book 6, at Page 102, on Plat of Amended Plat of Resubdivision of Block 21 of Ocean Beach Addition Number 3, as recorded in Plat Book 6, at Page 17, on Plat of Subdivision of Block 50 of Ocean Beach Addition Number 3, necorded in Plat Book 6, at Page 102, on Plat of Amended Plat of Resubdivision of Block 21 of Ocean Beach Addition Number 3, as recorded in Plat Book 6, at Page 17, on Plat of Subdivision of Block 50 of Ocean Beach Addition Number 3, necorded in Plat Book 7, at Page 48, all of the Public Records of Dade County, Florida, be and the same is hereby changed in name and shall hereafter be known as WASHINGTON AVENUE.

SECTION 2: That those certain highways shown on that certain Plat of Lake View Subdivision, recorded in Plat Book 14, at Page 42, of the Public Records of Dade County, Florida, and designated as Post Avenue, Prairie Avenue, Osborne Court, West Forty-ninth Street, and West Fifty-second Terrace, are hereby changed in name and shall hereafter be known as Black Hawk Avenue, Cherokee Avenue, Delaware Avenue, West Forty-ninth Court and West Fifty-first Terrace, respectively.

SECTION 3: That those certain highways shown on that certain Plat of Normandy Beach South, recorded in Plat Book 21, at Page 54, of the Public Records of Dade County, Florida, and designated as Indian Creek Drive and Biscayne Drive, are hereby changed in name and shall hereafter be known as Albacore Drive and Bonita Drive, respectively.

SECTION 4: That those certain highways shown and designated as Miami Avenue and Collins Avenue on that certain Plat of South Beach Park, recorded in Plat Book 6, at Page 77, of the Public Records of Dade County, Florida, are hereby changed in name and shall hereafter be known as South Washington Avenue and South Collins Avenue, respectively.

SECTION 5: That those certain undesignated highways; one extending from Biscayne Street to the Northerly line of Blocks 7 and 8 of South Beach Park, and the other from Biscayne Street to the Northerly line of Blocks 6 and 7 of said South Beach Park, said South Beach Park being recorded in Plat Book 6, at Page 77, of the Public Records of Dade County, Florica, are hereby named and shall hereafter be known as South Washington Avenue and South Collins Avenue, respectively.

SECTION 6: That that certain undesignated highway extending from the North line of Harrison & Hayes' Subdivision, recorded in Plat Book 9, at Page 73, of the Public Records of Dade County, Florida, to Fifteenth Street and running through Block 77 of Fisher's First Subdivision of Alton Beach, recorded in Plat Book 2, at Page 77, of said Public Records, be and the same is hereby named and shall hereafter be known as Ocean Drive.

SECTION 7: That those certain highways shown and designated as Fifty-eighth Street, Fifty-ninth Street, Sixtieth Street, Sixty-first Street, Sixty-third Street, Ouimet Avenue, and Prairie Avenue, on that certain Plat of Beach View Addition, recorded in Plat Book 16, at Page 10, of the Public Records of Dade County, Florida, are hereby changed in name and shall hereafter be known as West Fifty-eighth Street, West Fifty-ninth Street, West Sixtieth Street, West Sixty-first Street, West Sixty-third Street, Apache Avenue and Cherokee Avenue, respectively.

SECTION 5: That that certain highway lying between Blocks 12 and 13 of Beach View Addition as per Plat recorded in Plat Book 16, Page 10, of the Public Records of Dade County, Florida, be and the same is hereby named and shall hereafter be known as West Sixty-second Street.

SECTION 9: That that certain highway shown on those certain Plats of Amended Plat of Belle Isle, recorded in Plat Book 5, at Page 11, and of El Retiro, recorded in Plat Book 17, at Page 34, of the Public Records of Dade County, Florida, and designated as Bridge Road, be and the same is hereby changed in name and shall hereafter be known as Venetian Way.

SECTION 10: That those certain highways shown on that certain Plat of Rivo Alto recorded in Plat Book 7, at Page 74, of the Public Records of Dade County, Florida, are hereby named and designated as follows: That certain highway lying adjacent to and easterly of Blocks 1 and 2 shall hereafter be known as West Rivo Alto Drive; that certain highway lying adjacent to and Westerly of Blocks 3 and 4, shall hereafter be known as East Rivo Alto Drive; that certain highway lying between Blocks 5 and 6 shall hereafter be known as First Rivo Alto Terrace; that certain highway lying between Blocks 6 and 7 shall hereafter be known as Second Rivo Alto Terrace; that certain highway lying between Blocks 8 and 9 shall hereafter be known as Third Rivo Alto Terrace; and that certain highway lying between Blocks 9 and 10 shall hereafter be known as Fourth Rivo Alto Terrace.

SECTION 11: That those certain undesignated highways shown on that certain Plat of Di Lido, recorded in Plat Book 5, at Page 36, of the Public Records of Dade County, Florida, are hereby named and designated as follows: That certain highway lying adjacent to and easterly of Blocks 2 and 3, Part of Lot A and Part of Block 1, and extending from the easterly line of Lot 5 of said Block 1 to the center of Lot A shall hereafter be known as West Di Lido Drive; that certain highway lying adjacent to and westerly of Blocks 4 and 5, Part of said Lot A and Part of said Block 1, and extending from the said easterly line of Lot 5, Block 1 to the said center of Lot A shall hereafter be known as East Di Lido Drive; that certain highway lying between Blocks 6 and 7 shall hereafter be known as First Di Lido Terrace; that certain highway lying between Blocks 7 and 8 shall hereafter be known as Second Di Lido Terrace; that certain highway lying between Blocks 8 and 9 shall hereafter be known as Third Di Lido Terrace; that certain highway lying between Blocks 9 and 10 shall hereafter be known as Fourth Di Lido Terrace; that certain highway lying between Blocks 11 and 12 shall hereafter be known as Fifth Di Lido Terracc; that certain highway lying between Blocks 12 and 13 shall hereafter be known as Sixth Di Lido Terrace; that certain highway lying between Blocks 13 and 14 shall hereafter be known as Seventh Di Lido Terrace; and that certain highway lying between Blocks 14 and 15 shall hereafter be known as Eighth Di Lido Terrace. That those certain undesignated highways shown

SECTION 12: That those certain undesignated highways shown on that certain Plat of San Marino, recorded in Plat Book 9, Page 22, of the Public Records of Dade County, Florida, are hereby named and designated as follows: That certain highway lying adjacent to and Easterly of Blocks 1 and 2 shall hereafter be known as West San Marino Drive; that certain highway lying adjacent to and ¥esterly of Blocks 3 and 4 shall hereafter be known as East San Marino Drive; that certain highway lying between Blocks A and 5 shall here-after be known as First San Marino Terrace; that certain high-way lying between Blocks 5 and 6 shall hereafter be known as Second San Marino Terrace; that certain highway lying between Blocks 7 and 8 shall hereafter be known as Third San Marino Terrace, and that certain highway lying between Blocks 8 and B shall hereafter be known as Fourth San Marino Terrace.

SECTION 13: That those certain highways known and designat-ed as West Drive and East Drive on that certain Plat of Corrected Plat Star Island, recorded in Plat Book 31, Page 60, of the Public Records of Dade County, Florida, are hereby changed in name and shall hereafter be known as West Star Island Drive and East Star Island Drive, respectively.

That those certain undesignated highways shown SECTION 14: on that certain Plat of Mid-Golf Subdivision, recorded in Plat Book 4, Page 200, of the Public Records of Dade County, Florida, are hereby named and designated as follows: That certain highway lying between Blocks 1 and 2, shall hereafter be known as West Twenty-third Street, and that certain highway lying adjacent to and northerly of Block 2, shall hereafter be known as West Twenty-eighth Street.

That that certain highway known and designated SECTION 15: as Forty-first Street on that certain Plat of Flamingo Bay Subdivision No. 1, recorded in Plat Book 6, Page 101, of the Public Records of Dade County, Florida, be and the same is hereby changed in name and shall hereafter be known as West Forty-first Street.

SECTION 16: That that certain undesignated highway lying between Blocks 1 and 3 of Nursery Subdivision as shown on that certain Plat recorded in Plat Book 23, Page 66, of the Public Records of Dade County, Florida, be and the same is hereby named and designated and shall hereafter be known as West Forty-second Street.

That that certain highway shown and designated as Private Roadway on that certain Plat of the Subdivision of the North 230 Feet of Lot 1 of the Subdivi-sion of Block 80, recorded in Plat Book 34, at Page 25, of the Public Records of Dade County, Florida, be and the same is hereby named and shall hereafter be known as Thirteenth SECTION 17: Terrace.

SECTION 18: All persons, firms, or corporations owning property or residing upon any of the foregoing streets as re-named or designated herein are required to observe the provisions of this ordinance in designating or numbering residences or posting signs or markers which may designate any of the foregoing streets.

That all ordinances or parts of ordinances in SECTION 19: conflict herewith are hereby repealed.
