ORDINANCE NO. 305

AN ORDINANCE OF THE CITY OF MIAMI BEACH, FLORIDA, AMENDING SECTION D, ORDINANCE, NO. 256 OF SAID CITY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MIAMI BEACH, FLORIDA:

SECTION 1: That Section D, down to subdivision (a), of Ordinance No. 256 be amended to read as follows:

"SECTION "D" - PRIVATE FIRE SERVICE PROTECTION.

1. There shall be no charge for private fire service.

The cost of the installation of Private Fire Service is to be paid for by the owner at actual cost plus 10%.

The Water Department shall install Fire Line connections up to the property line upon the owner signing a Regular Form of Contract containing the following conditions:"

<u>SECTION 2</u>: That the following paragraph be added in said Section D, between paragraphs (f) and (g):

"(ff) The right is reserved by the Water Department to shut off the supply at any time the regular domestic service is shut off."

SECTION 3: These amendments shall take effect April 1st, 1932.

SECTION 4: All other parts of said ordinance shall remain in full force and effect except as hereby changed.
