

ORDINANCE NO. 306

AN ORDINANCE OF THE CITY COUNCIL  
OF THE CITY OF MIAMI BEACH, FLOR-  
IDA, TO AMEND ORDINANCE NO. 289,  
OF THE CITY OF MIAMI BEACH, FLOR-  
IDA, BEING THE ZONING ORDINANCE  
OF SAID CITY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MIAMI  
BEACH, FLORIDA:

SECTION 1: That Section 7 of Ordinance No. 289 of the  
City of Miami Beach, Florida, known as the  
Zoning Ordinance of Miami Beach, Florida, entitled "BA"  
Business District, be and it is hereby amended by adding  
thereto immediately after the line, "(3) Meat Markets,  
(except the handling of live poultry.)" the line, "(4)  
Mortuaries."

SECTION 2: That Section 8 of said Ordinance No. 289,  
entitled "BB" Business District be and the  
same is hereby amended by adding thereto immediately  
after the line, "(13) Retail electric stores and repair  
shops," the line, "(14) Fish Markets."


SECTION 3: That Section 9 of said Ordinance No. 289,  
entitled "BC" Business District be and the  
same is hereby amended by adding thereto immediately  
after the line, "(22) Service Stations," the line, "(23)  
Pawn Shops."

SECTION 4: That Section 11 of said Ordinance No. 289,  
entitled "BE" Business District be and the  
same is hereby amended by adding thereto immediately  
after the line, "(2) Oil and/or gasoline storage tanks,  
subject to approval and permit by the City Council," the  
line, "(3) Live poultry markets and/or slaughtering of  
poultry."


SECTION 5: All ordinances or parts of ordinances in con-

after its passage, approval and posting.



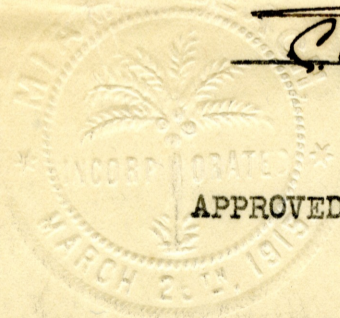

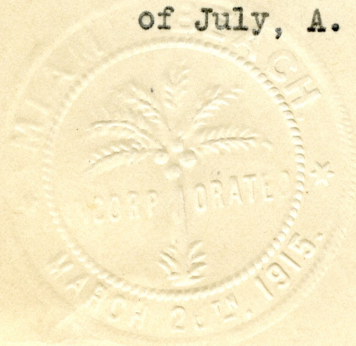
