

ORDINANCE NO. 309

AN ORDINANCE ESTABLISHING A SCHEDULE OF SALARIES TO BE PAID TO EMPLOYEES OF THE CITY OF MIAMI BEACH, FLORIDA, AND FIXING THE RATES THEREOF.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MIAMI BEACH, FLORIDA:

That a schedule of rates of salaries for employees of the City of Miami Beach be and the same is hereby established as follows:

SECTION 1:

SECTION 2: Any and all other salaries for employees not specifically mentioned, nor covered by, this ordinance shall be fixed by the department head, with the approval of the City Manager, and shall not exceed the sum of One Hundred Thirty-five Dollars (\$135.00) per month.

SECTION 3: Ordinance No. 302 and all other ordinances, or parts of ordinances, in conflict with this ordinance are hereby repealed.

SECTION 4: This Ordinance shall become effective on and after July First, 1932.


