

ORDINANCE NO. 322

AN ORDINANCE OF THE CITY OF MIAMI BEACH, FLORIDA, AMENDING ORDINANCE NO. 311 BEING AN ORDINANCE OF THE CITY OF MIAMI BEACH, FLORIDA, IMPOSING LICENSES AND OTHER TAXES ON PRIVILEGES, BUSINESSES, OCCUPATIONS AND PROFESSIONS CARRIED ON AND ENGAGED IN WITHIN SAID CITY, AND PRESCRIBING PENALTIES FOR THE EXERCISING OF SUCH PRIVILEGES OF CARRYING ON SUCH BUSINESS, OCCUPATIONS OR PROFESSIONS WITHOUT A LICENSE OR OTHER FAILURE TO COMPLY WITH THE PROVISIONS THEREOF.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MIAMI BEACH, FLORIDA:

SECTION 1: That Section 5 of Ordinance No. 311 of the City of Miami Beach be and the same is hereby amended by eliminating therefrom the following paragraph:

"Provided, further, that lumber and/or building material dealers without established places of business in Miami Beach, on foot or from wagons, trucks or other vehicles, selling or delivering in the City of Miami Beach, shall pay a fee of \$ 50.00"

and inserting therein, the following:

"Lumber and/or building material dealers \$ 50.00".

SECTION 2: That Section 5 of said Ordinance No. 311 of the City of Miami Beach be and the same is hereby amended by eliminating therefrom the following:

"BAGGAGE AND TRANSFER business with established place of business in Miami Beach \$ 25.00

"BAGGAGE AND TRANSFER business without an established place of business in Miami Beach \$ 50.00

and inserting therein, the following:

"BAGGAGE AND TRANSFER business \$ 25.00

SECTION 3: That said Section 5 of said Ordinance No. 311 be and the same is hereby amended by eliminating therefrom the following:

"BOOT AND SHOE REPAIR (With shop in Miami Beach. . \$ 10.00

"BOOT AND SHOE REPAIR (Without repair shop in Miami Beach) for each vehicle or agency used in soliciting collecting or delivery \$ 25.00."

and inserting therein, the following:

"BOOT AND SHOE REPAIR SHOP \$ 10.00."

SECTION 4: That said Section 5 of said Ordinance No. 311 be and the same is hereby amended by eliminating therefrom the following:

"CATERERS, with established places of business in Miami Beach \$ 10.00

"CATERERS, without established place of business in Miami Beach \$ 25.00."

and inserting therein, the following:

"CATERERS \$ 10.00."

SECTION 5: That said Section 5 of said Ordinance No. 311 be and the same is hereby amended by eliminating therefrom the following:

"CLEANING AND PRESSING ESTABLISHMENTS, including RUG and CARPET CLEANING, with established place of business in Miami Beach, each establishment or agency \$ 25.00

"CLEANING AND PRESSING ESTABLISHMENTS, including RUG and CARPET CLEANING without established places of business in Miami Beach, on foot or from wagons, trucks or other vehicles, collecting or delivering . \$ 50.00."

and inserting therein the following:

"CLEANING AND PRESSING ESTABLISHMENTS including rug and carpet cleaning \$ 25.00."

SECTION 6: That said Section 5 of said Ordinance No. 311 be and the same is hereby amended by eliminating therefrom the following:

"LAUNDRIES, including HAND LAUNDRIES, with established places of business in Miami Beach, each establishment or agency \$ 25.00

"LAUNDRIES, including HAND LAUNDRIES, without established places of business in Miami Beach, on foot or from wagons, trucks or other vehicles, collecting or delivering \$ 50.00."

and inserting therein the following:

"LAUNDRIES \$ 25.00."

SECTION 7: That said Section 5 of said Ordinance No. 311 be and the same is hereby amended by eliminating therefrom the following:

"FUNERAL DIRECTORS AND UNDERTAKERS, with established places of business in Miami Beach \$ 25.00

"FUNERAL DIRECTORS and UNDERTAKERS, without established places of business in Miami Beach \$ 50.00."

and inserting therein the following:

"FUNERAL DIRECTORS and UNDERTAKERS \$ 25.00

SECTION 8: That said Section 5 of said Ordinance No. 311
be and the same is hereby amended by eliminating
therefrom the following:

"INTERIOR DECORATORS, whose business is confined to
furnishing curtains, draperies, hangings, furniture
etc., exclusively, with established place of business
in Miami Beach \$ 25.00

"ditto without established place of business in
Miami Beach \$ 50.00."

and inserting therein the following:

"Interior Decorators, whose business is confined to
furnishing curtains, draperies, hangings, furniture
etc., exclusively \$ 25.00."

SECTION 9: That said Section 5 of said Ordinance No. 311
be and the same is hereby amended by eliminating
therefrom the following:

"LANDSCAPE CONTRACTORS, with established place of
business in Miami Beach \$ 15.00

"LANDSCAPE CONTRACTORS, without established place
of business in Miami Beach \$ 30.00."

and inserting therein the following:

LANDSCAPE CONTRACTORS \$ 15.00."

SECTION 10: That said Section 5 of said Ordinance No. 311
be and the same is hereby amended by eliminating
therefrom the following:

"PHOTOGRAPHERS with established places of business
in Miami Beach \$ 15.00

"PHOTOGRAPHERS, COMMERCIAL, without established
places of business in Miami Beach, and/or solicitors
or collectors of work \$250.00

and inserting therein the following:

"PHOTOGRAPHERS, (not itinerant) \$ 15.00."

SECTION 11: That said Section 5 of said Ordinance No. 311
be and the same is hereby amended by eliminating
therefrom the following:

"SIGN-WRITERS, with Sign shop in Miami Beach . . . \$ 25.00


"SIGN-WRITERS, without Sign Shop in Miami Beach . \$ 50.00. "

and inserting therein the following:


"SIGN-WRITERS \$ 25.00."




