and inserting therein the following:

SECTION 10: That said Section 5 of said Ordinance No. 311
be and the same is hereby amended by eliminating
therefrom the following:
"PHOTOGRAPHERS with established places of business in Miami Beach
*PHOTOGRAPHERS COMMERCIAL without established
*PHOTOGRAPHERS, COMMERCIAL, without established places of business in Miami Beach, and/or solicitors or collectors of work
and inserting therein the following:
"PHOTOGRAPHERS, (not itinerant) \$ 15.00."
SECTION 11: That said Section 5 of said Ordinance No. 311
be and the same is hereby amended by eliminating
therefrom the following:
