

ORDINANCE NO. 323

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MIAMI BEACH, FLORIDA, AMENDING SECTION 3 OF ORDINANCE NO. 297, AS AMENDED BY ORDINANCE NO. 314, FIXING LICENSE FEES OF AWNING CONTRACTORS.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MIAMI BEACH, FLORIDA:

SECTION 1. That Ordinance No. 314, passed and adopted October 21st, 1932, be and the same is hereby repealed.

SECTION 2. That Paragraph "B" of Section 3 of Ordinance No. 297, be and the same is hereby amended to read as follows:

"B. If the information as stated in the application is satisfactory and the insurance is in correct form the License Department shall collect from the applicant a license fee in the sum of Fifty Dollars (\$50.00) and shall issue to said applicant a license to do business as an Awning Contractor within the City of Miami Beach from that date until the following October 31st, inclusive."

SECTION 3. That Paragraph "C" (and note following same) and Paragraph "D" of Section 3 of Ordinance No. 297 be and the same are hereby repealed.

SECTION 4. That Paragraph "E" and "G" of Section 3 of Ordinance No. 297 be and the same are hereby amended to read as follows:


"E. It is further provided that Awning Contractors' Licenses shall not be issued to a bankrupt and that the granting of a petition in bankruptcy, either voluntary or involuntary, as against the holder of an Awning Contractor's License shall automatically revoke said license.

Said revoked license may be renewed upon the discharge of the alleged bankrupt from bankruptcy, upon application to and approval by the City Council."


"G. It shall be unlawful to transact the business of Awning Construction under any other license except an Awning Contractor's License, and no other license shall be required of an Awning Contractor to transact the business of Awning Contractor."

SECTION 5. All Ordinances and parts of Ordinances in conflict herewith are hereby repealed.






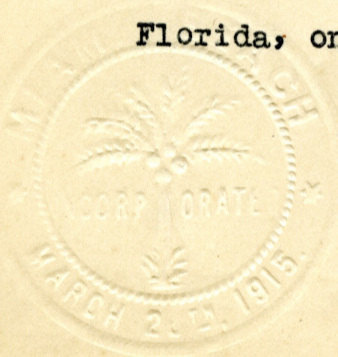
