


ORDINANCE NO. 327

AN ORDINANCE OF THE CITY COUNCIL  
OF THE CITY OF MIAMI BEACH, FLORIDA,  
VACATING A CERTAIN EASEMENT FOR PUB-  
LIC UTILITIES IN BLOCK 26, LAKE VIEW  
HEIGHTS SUBDIVISION.


BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF  
MIAMI BEACH, FLORIDA:

That that certain easement, ten (10) feet in width  
dedicated to the use of the City of Miami Beach, Florida,  
for the installation and maintenance of sewers, watermains  
gaspipes, power, telephone and telegraph wires, installed  
by the City of Miami Beach or any public utility company,  
having a franchise from said City for any one of such pur-  
poses and for no other purpose, the center line of which is  
the West boundary line of Lot 3 and the East boundary line  
of Lots 1 and 2, in Block 26, of Lake View Heights Subdivi-  
sion, as said easement is indicated by dotted lines on a  
plat recorded in Plat Book No. 27 at Page 5, of the Public  
Records of Dade County, Florida, be and the same is hereby  
vacated to the same extent as if said easement had never  
been dedicated.



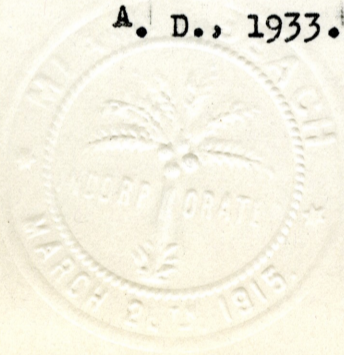
