AN ORDINANCE OF THE CITY COUNCIL
OF THE CITY OF MIAMI BEACH, FLORIDA,
AMENDING ORDINANCE NO. 289, BEING
THE ZONING ORDINANCE OF THE CITY
OF MIAMI BEACH, FLORIDA.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MIAMI BEACH,
FLORIDA:

SECTION 1: That the Use Regulations of the following described
area, to-wit:

Lots 9, 10, 11, 12, 13 and 14 of Block
79A, all of Block 79B and all of Block
79C of the Resubdivision of Blocks
67 and 79 of the Alton Beach Realty
Company's Bay Front Subdivision, all in
the City of Miami Beach, Florida, as
recorded in Plat Book 16, Page 1, of the
Public Records of Dade County, Florida.

be and they are hereby amended, changed and modified, so as to
change said area from its present Use District classification
under said Ordinance No. 289 to what is known as "RD" Single
Family District.

SECTION 2: All ordinances and parts of ordinances in conflict
herewith are hereby repealed.

SECTION 3: This ordinance shall take effect immediately after
its passage, approval and posting.



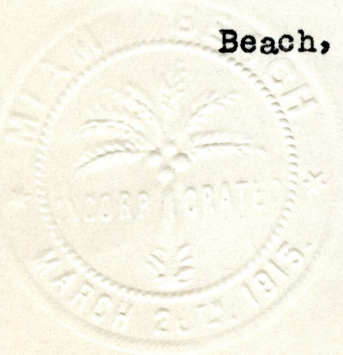
