

ORDINANCE NO. 334

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MIAMI BEACH, FLORIDA, AMENDING SECTION 11 OF ORDINANCE NO. 285, AS AMENDED BY ORDINANCES NOS. 295, 315 AND 321 OF SAID CITY BEING "AN ORDINANCE DEFINING, REGULATING AND GOVERNING CONTRACTORS OF CONSTRUCTION, INCLUDING ALL BRANCHES NOT INCLUDED IN OTHER ORDINANCES, WITHIN THE CITY LIMITS OF MIAMI BEACH, FLORIDA; REQUIRING EXAMINATION OF ALL SUCH CONTRACTORS; PRESCRIBING THE TIME WHEN SUCH EXAMINATIONS SHALL BE CONDUCTED; SPECIFYING AND FIXING THE FEE FOR EXAMINATION; SPECIFYING AND FIXING THE AMOUNT OF THE OCCUPATIONAL LICENSE FEE FOR SUCH CONTRACTORS; CREATING A BOARD OF EXAMINERS FOR CONTRACTORS; DEFINING THE DUTIES AND POWERS OF THE BOARD; AND PROVIDING PENALTIES FOR THE VIOLATION OF THIS ORDINANCE."

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MIAMI BEACH, FLORIDA:

SECTION 1: That Section 11 of Ordinance No. 285, as amended by Ordinances Nos. 295, 315 and 321 of the City of Miami Beach, Florida, be and the same is hereby amended by eliminating therefrom the lines:

"General Contractors, without an established place of business in Miami Beach \$100.00

General Contractors, with an established place of business in Miami Beach 50.00"

and substituting therefor the following lines:

"General Contractors 50.00".

SECTION 2: All ordinances and parts of ordinances in conflict herewith are hereby repealed.



D., 1933, and that said ordinance remained posted for a period of at least thirty days in accordance with the requirements of the City Charter of the said City of Miami Beach.
