

ORDINANCE NO. 341

AN ORDINANCE OF THE CITY OF
MIAMI BEACH, FLORIDA, AMENDING
ORDINANCE NO. 289, BEING THE
ZONING ORDINANCE OF SAID CITY
SO AS TO CHANGE THE USE REGULA-
TION OF PROPERTY FRONTING ON
TWENTY-THIRD STREET BETWEEN LIBER-
TY AND PARK AVENUES.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MIAMI
BEACH, FLORIDA:

Section 1: That the use regulation of the following
described property, to-wit:


Lots 1, 3, 5, 7 and 9, Block 1 and Lots
7, 8, 9, 10 and 11, Block 3, all in
Ocean Front Property of the Miami Beach
Improvement Company, in the City of
Miami Beach, as same is recorded in Plat
Book 5 at Pages 7 and 8, Public Records
of Dade County, Florida

be and the same is hereby amended, changed and modified,
so as to change said properties from their present use
regulation "BB" Business District to what is known as
"BA" Business District, as said use regulation districts
are described in Sections 8 and 7 respectively of said
Ordinance No. 289.


Section 2: All ordinances and parts of ordinances in

with law.



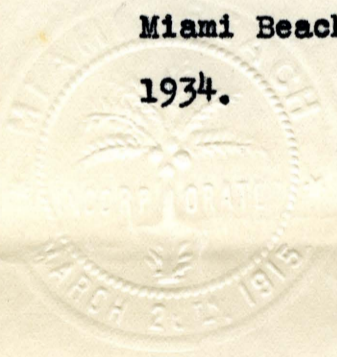
